Tool Search: English Learners (EL)

The English Learners (EL) tool allows schools and districts to manage student EL programs, assessments, services, and accommodations. The tool provides a central location for managing EL information, such as the date the student was identified as EL, when the student entered/exited an EL program, when the student is expected to leave an EL program, and First Year/Second Year Monitoring data. For students who exited and/or re-entered an EL program, a historical record is kept and displayed on the tab, which can be viewed in both State and District Editions of Infinite Campus.

Some EL fields are specific to your state. All other fields in the EL tool do not require unique, statespecific data. However, many of these fields are required, and data entry is necessary. See the English Learners (EL) article for more information on these fields.

## **EL Tool**

The EL tool allows schools and districts to manage student English Learners (EL) programs. The EL tool was designed to provide a single area for managing EL information and pulling data for state and federal reports. Fields that are specific to Hawaii are described below. English Language Development (ELD) represents the social, instructional, and academic language students use to engage with peers, educators, and the school curriculum. Classroom teachers



should use these for planning and implementing language instruction and assessment. ELD instruction is specifically designed to help ELs learn and acquire "foundational" English to a level of proficiency to help students be successful in mainstream English classrooms.

Code	Description	Definition
1	Self Contained	Typically an ESL class with only EL Program students; all subject matter taught to EL Program students by their ESL classroom teacher and no pull-out ESL instruction is used.
2	Inclusionary Support	Pending further information from the Hawaii Department of Education.
3	Pull-Out	When students are withdrawn from their regular classrooms for one or more periods a week for special classes of ESL instruction in small groups.
4	Other	When Other is selected, users MUST enter descriptive comments in the Other EDL Instructional Setting field.
