## Academic Planning

Academic Planning- Prerequisite or Concurrent Planning Rule not considering credits earned (SIS-137815)

An issue was identified with Academic Plans not respecting the Prerequisite and the Prerequisite or Concurrent Planning Rules in the Course Planner for courses to which the rules applied. If a student had taken but failed a prerequisite course and did not receive credit, the Planner looked for the presence of the course but dismissed the credit requirement needed to satisfy the rule. This allowed students to add courses to their plan even if they failed to meet the prerequisite requirements. This has been fixed.

For sections meetings in future terms, the first day of the section is used as the effective date (first day of the first term in which the section meets), and and returns one row per Blended Learning Group and includes summary counts of students' Blended Learning Group assignments as of the first day of the section.

Previously, student enrollments started after the first day of the first term in which a section met were not being included in the Blended Learning Summary counts. This has been corrected.
