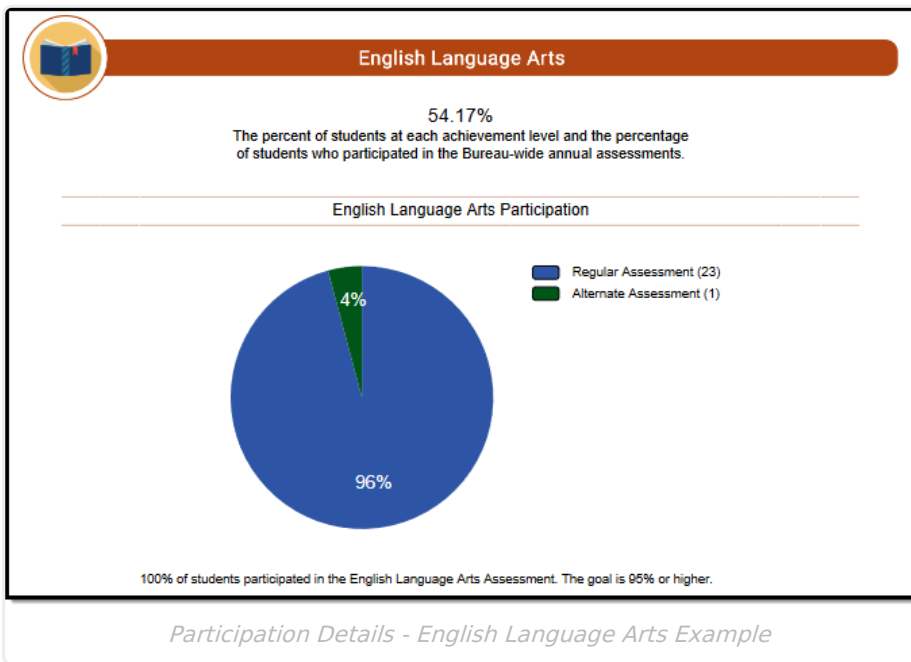

Participation reflects the number of students who have participated in the Bureau-wide annual assessment. Students who do not take the assessment are counted as a non-participant in the participation calculation.



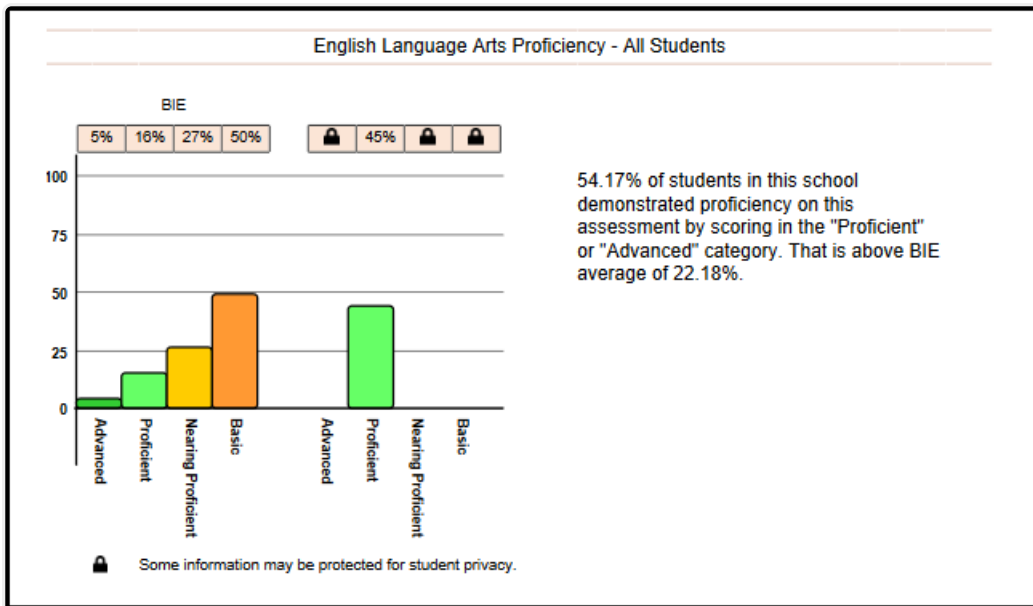

Proficiency

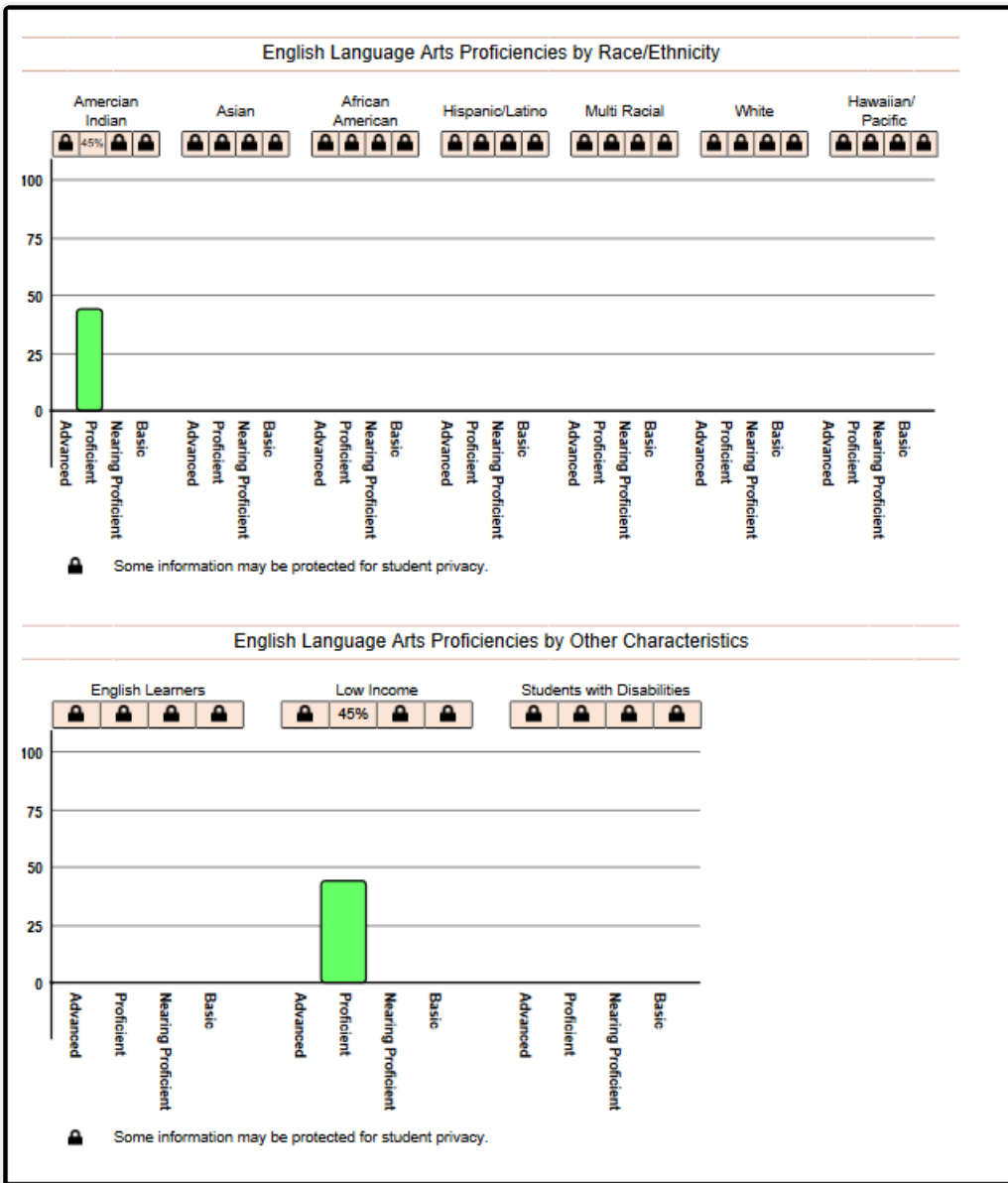
Proficiency reflects the level of understanding students have reached based on a standard assessment. Proficiency levels include: Advanced, Proficient, Nearing Proficient, and Basic. Students comprising the Proficient and Advanced percentages have demonstrated an understanding at or above the standard for their grade level.

If a demographic subgroup has **ten or fewer** students, a lock icon displays for the subgroup to protect student privacy and prevent student identification.

Skill Level	Description
Advanced	Reflects the percentage of students whose proficiency level is Advanced (Level 4).
Proficient	Reflects the percentage of students whose proficiency level is Proficient (Level 3).
Nearing Proficient	Reflects the percentage of students whose proficiency level is Nearing Proficient (Level 2).
Basic	Reflects the percentage of students whose proficiency level is Basic (Level 1).
