





#### **Referral Date**

Indicates the date of the student's referral to special education.

### **Referral Type**

Indicates the type of referral - Initial, Other or Reevaluation.

Indicates the reason(s) for the referral. Options in this field are populated in the Attribute/Dictionary.

#### **Referral Source**

Indicates the source of the referral. Options in this field are populated in the Attribute/Dictionary.

## **Referred By**

Indicates the individual who referred the student (school staff, doctor, etc.). Options in this field are populated in the Attribute/Dictionary.

#### **Permission Sent Date (first attempt)**

Lists the date permission for evaluation was first sent to parents.

#### **Received Consent Date**

Lists the date the district received consent for evaluation from the parents.
