- Schools now display in alphabetical order on the Create Activity (first screen) and the Link to Portal (fourth screen) of the Activity Builder.
- A warning message was added to the Activity Roster that warns users when they are about to leave the forms screen with unsaved changes.
- Emancipated students could not sign forms when opening the form from Activity Registration. This issue was corrected.
- When students are manually added to an Activity Roster, the students grade level now displays immediately on the roster.

## **Custom**

### Custom Outline Links URL Updated to Max Size of Varchar 2000 (SIS-134772)

The URL field for Custom Outline Links had a limit of 800 characters, preventing users from creating links for very long URLs such as Ad Hoc Pivot Tables. To correct this issue, the field has been changed to a maximum length of Varchar 2000 (the longest some web browsers support).

#### Custom Tool Placement Editor No Longer Focuses on Sort Name (SIS-152391)

When selecting the New Tool Mapping button in the Custom Tool Placement Editor, the tool was focusing on the Sort Name (Optional) field instead of the first field on the form. This issue was corrected.
