Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	<p>Report a Student Academic Record for students in grade levels 9-12 who have a Student School Association record for the scope year without diploma array if Diploma Date is not populated (Public only).</p> <ul style="list-style-type: none"> • If a student has multiple Student School Associations, report a Student Academic Record for each if they are in different schools. • Report a Student Academic Record with diploma array when the Diploma Date and Diploma Type are populated for the scope year, even when the diploma period is 'Summer'. <ul style="list-style-type: none"> ◦ If diploma period = 'SU', then report in the config year that is equal to the graduation date year ◦ Otherwise, report in the config year that is equal to the end year of the Top Enrollment that meets all of the other criteria, and where the graduation date falls within the start and end dates of the School Year the Enrollment is in.

School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

Action	Trigger
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.
Delete	If a resource is toggled to 'OFF' after data has sent and an action is performed that would trigger a delete, that data will remain in the ODS until a resync is done.

Action	Trigger
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed-Fi Identity Mapping table.
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.

Action	Trigger
Delete/Post	If any part of the Natural Key Changes <ul style="list-style-type: none"> If the District Number changes all data will remain under the old number. The delete tool would need to be used to remove all old data.
Delete/Post	If an Ed-Fi ID changes, this will happen with the cascading deletes from the Ed-Fi ID Change trigger.
Delete/Post	If the End Year the transcript record or diploma record is aligned to changes.
Delete/Post	If the Term Descriptor is changed.
Delete/Post	If the natural key changes all dependent resources will delete/post.

Scope Year Logic

Logic
Records will send to each scope year in which the Course Transcript record is posted.
Records will only post to the Student Academic Records for the year the diploma date occurs in but Student Academic Records will post to all scoped years. <ul style="list-style-type: none"> The Diploma Date must be on or after the school year's start date and on or before the school year's end date defined in the School Years editor. If blank, the default start date of 7/1/xxxx and end date of 6/30/xxxx are used.
Data will only send for years that have a valid configuration.
