NH	Not Homeless	Student is not homeless.
SH	Shelters	Homeless primary night time residence is a shelter and student is <u>not</u> served with McKinney-Vento (homeless) grant funds.
SF	Shelters McKinney-Vento funded	Homeless primary night time residence is a shelter and student is served with McKinney-Vento (homeless) grant funds.
SY	Shelters MV Funded (Unaccompanied Youth)	Homeless primary night time residence is a shelter and student is an unaccompanied youth (not in physical custody of parent or guardian) served with McKinney-Vento (homeless) grant funds.

Code	Description	Definition
SN	Shelters (Unaccompanied Youth)	Homeless primary night time residence is a shelter and student is an unaccompanied youth (not in the physical custody of parent or guardian) not served with McKinney-Vento (homeless) grant funds.
US	Unsheltered	Homeless primary night time residence is unsheltered (e.g., cars, parks, campgrounds, abandoned buildings, substandard or inadequate housing, etc.) and student is not served with McKinney-Vento (homeless) grant funds.
UF	Unsheltered McKinney-Vento funded	Homeless primary night time residence is unsheltered (e.g., cars, parks, campgrounds, abandoned buildings, substandard or inadequate housing, etc.) and student is served with McKinney-Vento (homeless) grant funds.
UY	Unsheltered MV Funded (Unaccompanied Youth)	Homeless primary nighttime residence is unsheltered (e.g., cars, parks, campgrounds, abandoned buildings, substandard or inadequate housing, etc.) and student is an unaccompanied youth (not in the physical custody of parent or guardian) served with McKinney-Vento (homeless) grant funds.

DF	Doubled Up McKinney-Vento funded	Homeless primary night time residence is doubled-up (sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason) and student is served with McKinney-Vento (homeless) grant funds.

DY	Doubled Up MV Funded (Unaccompanied Youth)	Homeless primary nighttime residence is doubled-up (sharing housing of other persons due to loss of housing, economic hardship, or a similar reason) and student is an unaccompanied youth (not in the physical custody of parent or guardian) served with McKinney-Vento (homeless) grant funds.
DN	Doubled Up (Unaccompanied Youth)	Homeless primary nighttime residence is doubled-up (sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason) and student is an unaccompanied youth (not in the physical custody of parent or guardian) not served with McKinney-Vento (homeless) grant funds.
HM	Hotel/Motel	Homeless primary night time residence is a hotel or motel and student is not served with McKinney-Vento (homeless) grant funds.
HF	Hotel/Motel McKinney-Vento funded	Homeless primary night time residence is a hotel or motel and student is served with McKinney-Vento (homeless) grant funds.
HY	Hotel/Motel MV Funded (Unaccompanied Youth)	Homeless primary night time residence is a hotel or motel and student is an unaccompanied youth (not in the physical custody of parent or guardian) served with McKinney-Vento (homeless) grant funds.
HN	Hotel/Motel (Unaccompanied Youth)	Homeless primary night time residence is hotel or motel and student is an unaccompanied youth (not in the physical custody of parent or guardian) not served with McKinney-Vento (homeless) grant funds.

Homeless status can be assigned to a student at any point of the enrollment period. If a student is determined Homeless at any point in the school year, the student will report as Homeless for the entire enrollment period. The amount of time the student is deemed homeless is not considered.
