

The Student Snapshot Template reports data from student enrollments as well as demographics information.

In the <u>Campus.2144 Release Pack (October 2021)</u>, the December Reporting Period was removed from the PIMS Student Snapshot Template. It has been added to the Special Education Extracts as the Student Template.

In the <u>Campus.2108 Release Pack (February 2021)</u>, the July Reporting Period was removed from the PIMS Student Snapshot Template. It has been added to the Special Education Extracts as the <u>July Student Snapshot Template Extract Type</u>.

Report Logic

The Student Snapshot Template reports records for all actively enrolled students as of the entered Effective Date. This report is the same as the <u>Student Template</u> except it includes the Reporting Date field.

Report Editor

Field	Description
Extract Type	Determines the type of PIMS Extract being generated.
Effective Date	Entered date causes the extract to report all students actively enrolled as of that date and/or all data as of this date. This date entered is considered the end date of the reporting period, unless it is a snapshot extract.
Format	Determines how the extract generates. Extracts can be generated in State Format (comma delimited) or HTML. Use the HTML format for reviewing and verifying data prior to submission to the state. Use the State Format for submitting the data to the Department of Education.
Report Protected Identities	When marked, last name, first name, middle name, suffix, and gender information reports from the <u>Protected Identity Information</u> section on the Identities editor, if the fields are populated.
Report All Addresses	When marked, address fields included in the report (Address 1, Address 2, City, State, Zip) report for each student record. When not marked, address information only reports for Special Education and CTE students only.
Ad hoc Filter	Select an existing ad hoc filter from which to report students. Only those students included in the Student Data Type filter and who meet the reporting population are included in the extract.
Select Grades	Select which grade levels to include on the report.
Calendars	At least one calendar must be selected when generating a PIMS extract. Calendars can be selected by the Active Year, by School or by Year. If a calendar is chosen in the Campus toolbar, that calendar is automatically be selected.



Field	Description
Report Generation	To generate the report immediately, use the Generate Extract option. To choose when the report generates, use the Submit to Batch option. Submit to Batch is useful when generating the report for several calendars or for larger amounts of data being reported. See the <u>Batch Queue</u> article for more information.

Generate the Student Snapshot Template

- 1. Select **Student Snapshot** from the **Extract Type** from the dropdown list.
- 2. Enter the **Effective Date** of the extract in *mmddyy* format or use the calendar icon to select a date.
- 3. Select the **Format** of the extract.
- 4. If desired, mark the **Report Protected Identities** checkbox.
- 5. If desired, mark the **Report All Addresses** checkbox.
- 6. If desired, select an Ad hoc Filter.
- 7. Select a **Grade** level for the extract.
- 8. Select the appropriate Calendar(s) from which to include data on the extract.
- 9. Click the **Generate Extract** button or the **Submit to Batch** button, if available. The extract displays in the selected format.
