## DTaP

Rule	Requirements
<b>1 dose 3-4 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 3 months and no older than 4 months old,</li> <li>the student receives 1 dose of the DT or DTaP/DTP vaccine, and</li> <li>the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance.</li> </ul>

Rule	Requirements
<p><b>2 doses 5-6 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 5 months and no older than 6 months old,</li> <li>• the student receives 2 doses of the DT or DTap/DTP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance, and</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance.</li> </ul>
<p><b>3 doses 7-18 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 7 months and no older than 18 months old,</li> <li>• the student receives 3 doses of the DT or DTap/DTP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance, and</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4 day tolerance.</li> </ul>
<p><b>4 doses under 4</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is no older than 47 months old,</li> <li>• the student receives 4 doses of the DT or DTap/DTP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than or equal to 6 months with a 4 day tolerance, and</li> <li>• the difference between the fourth dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<p><b>4 doses over 4</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 48 months old,</li> <li>• the student is in state grade: 94: Pre-Kindergarten (Age 2), 93: Pre-Kindergarten (Age 3), 92: Pre-Kindergarten (Age 4), 91: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, 31: SpEd-Overage, 32: SpEd-Overage 19, 33: SpEd-Overage 20, 34: SpEd-Overage 21,</li> <li>• the student receives 4 doses of the DT or DTap/DTP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than or equal to 6 months with a 4 day tolerance, and</li> <li>• the difference between the fourth dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>
<p><b>5 doses</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 48 months old,</li> <li>• the student is in state grade: 94: Pre-Kindergarten (Age 2), 93: Pre-Kindergarten (Age 3), 92: Pre-Kindergarten (Age 4), 91: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, 31: SpEd-Overage, 32: SpEd-Overage 19, 33: SpEd-Overage 20, 34: SpEd-Overage 21,</li> <li>• the student receives 5 doses of the DT or DTap/DTP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than or equal to 6 months with a 4 day tolerance,</li> <li>• the difference between the fourth dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance,</li> <li>• the difference between the fifth and previous dose is greater than or equal to 6 months with a 4 day tolerance, and</li> <li>• the difference between the fifth dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>3 doses after 7 years</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 84 months old,</li> <li>the student is in state grade: 91: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, 31: SpEd-Overage, 32: SpEd-Overage 19, 33: SpEd-Overage 20, 34: SpEd-Overage 21,</li> <li>the student receives 3 doses of the DT or DTap/DTP vaccine,               <ul style="list-style-type: none"> <li>the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance, and</li> <li>the difference between the third and previous dose is greater than or equal to 6 months with a 4 day tolerance AND</li> </ul> </li> <li>the student receives one dose of the Tdap vaccine,               <ul style="list-style-type: none"> <li>the difference between the dose and the student's birthdate is greater than or equal to 84 months with a 4 day tolerance.</li> </ul> </li> </ul>
<b>1 dose in Progress</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the DT or DTap/DTP vaccine, and</li> <li>the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<b>2 doses in Progress</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 2 doses of the DT or DTap/DTP vaccine, and</li> <li>the difference between the last dose and the effective date is less than 6 months with a 1 day tolerance.</li> </ul>
<b>3 doses in Progress</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 3 doses of the DT or DTap/DTP vaccine, and</li> <li>the difference between the last dose and the effective date is less than 6 months with a 1 day tolerance.</li> </ul>

## Polio

Rule	Requirements
<b>0-1 month</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Polio vaccine.

Rule	Requirements
<b>1 dose 2-4 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 4 months old,</li> <li>the student receives 1 dose of the IPV, OPV, or IPV/OPV combined Polio vaccine, and</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>
<b>2 doses 5-18 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 5 months, but no older than 18 months old,</li> <li>the student receives 2 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>3 doses 19 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 19 months old,</li> <li>the student is in state grade: 94: Pre-Kindergarten (Age 2), 93: Pre-Kindergarten (Age 3), 92: Pre-Kindergarten (Age 4),</li> <li>the student receives 3 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>the difference between the third and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>3 doses after 4</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 48 months old,</li> <li>the student receives 3 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third and previous dose is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<p><b>4 doses</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives 4 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth and previous dose is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<p><b>Students Enrolled Before 07/01/2020 4 doses</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is enrolled on 06/30/2020 or before,</li> <li>the student receives 4 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>the difference between the fourth and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<p><b>1 dose in Progress</b> <i>In Progress</i></p>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives 1 dose of the IPV, OPV, or IPV/OPV combined Polio vaccine, and</li> <li>the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<p><b>2 doses in Progress</b> <i>In Progress</i></p>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives 2 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine, and</li> <li>the difference between the last dose and the effective date is less than 6 months with a 1 day tolerance.</li> </ul>

## MMR

Rule	Requirements
<b>0-15 months</b> <i>No Requirements</i>	Students 0 - 15 months old are not required to receive any doses of the MMR vaccine.
<b>1 dose PK</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 16 months old,</li> <li>the student is in state grade: 94: Pre-Kindergarten (Age 2), 93: Pre-Kindergarten (Age 3), 92: Pre-Kindergarten (Age 4),</li> <li>the student receives one dose of the MMR or MMRV vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<b>2 doses K-12</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the MMR or MMRV vaccine,</li> <li>the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>In Progress</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the MMR or MMRV vaccine, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

## Hepatitis B

Rule	Requirements
<b>1 dose 0-1 month</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is between 0-1 month old, and</li> <li>the student receives one dose of the Hepatitis B vaccine.</li> </ul>
<b>2 doses 2-18 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 18 months old,</li> <li>the student receives two doses of the Hepatitis B vaccine, and</li> <li>the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>3 doses</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives three doses of the Hepatitis B or Hepatitis B - 3 Dose vaccine,</li> <li>the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>the difference between the third and second valid dose is greater than or equal to 56 days with a 4 day tolerance,</li> <li>the difference between the third and first valid dose is greater than or equal to 112 days with a 4 day tolerance, and</li> <li>the difference between the third dose and the student's birthdate is greater than or equal to 168 days with a 4 day tolerance.</li> </ul>
<b>2 doses In Progress</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the Hepatitis B vaccine, and</li> <li>the difference between the second dose and the effective date is less than 56 days with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose In Progress</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose of the Hepatitis B vaccine, and</li> <li>the difference between the second dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

## Hib

Rule	Requirements
<b>Age 0-1 month</b> <i>No Requirements</i>	Students age 0-1 month old are not required to receive any doses of the Haemophilus influenza, type B (Hib) vaccine.
<b>Age 5 and older</b> <i>No Requirements</i>	Students 60 months old and older are not required to receive any doses of the Haemophilus influenza, type B (Hib) vaccine.
<b>1 dose Age 2-3 months</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 2 months, but no older than 3 months old,</li> <li>the student receives one dose of the Haemophilus influenza, type B (Hib) or Hib 3-dose series (Hib-3) vaccine, and</li> <li>the difference between the dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>



Rule	Requirements
<p><b>2 doses Age 4-5 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 4 months, but no older than 5 months old,</li> <li>• the student receives two dose of the Haemophilus influenza, type B (Hib) or Hib 3-dose series (Hib-3) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<p><b>3 doses &lt;7 months 1st shot</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is no older than 11 months old,</li> <li>• the student receives three dose of the Haemophilus influenza, type B (Hib) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 6 months with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the third and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<p><b>3 doses 7-11 months 1st shot</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is no older than 11 months old,</li> <li>• the student receives three dose of the Haemophilus influenza, type B (Hib) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 7 months with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 11 months with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the third and previous dose is greater than 56 days with a 4 day tolerance.</li> </ul>

Rule	Requirements
<p><b>3 doses Hib 3 dose 7-11 months 1st shot</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives three dose of the Hib 3-dose series (Hib-3) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 11 months with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 56 days with a 4 day tolerance, and</li> <li>• the difference between the third dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<p><b>3 doses after 12-59 months</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 12 months, but no older than 59 months old,</li> <li>• the student receives three dose of the Haemophilus influenza, type B (Hib) or Hib 3-dose series (Hib-3) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 11 months with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 56 days with a 4 day tolerance, and</li> <li>• the difference between the third dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<p><b>2 doses Hib-3 after 1 year</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 12 months old,</li> <li>• the student receives three dose of the Hib 3-dose series (Hib-3) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>• the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.</li> </ul>

Rule	Requirements
<p><b>4 doses</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 12 months old,</li> <li>• the student receives four dose of the Haemophilus influenza, type B (Hib) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 11 months with a 4 day tolerance,</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the student's birthdate is less than 11 months with a 4 day tolerance,</li> <li>• the difference between the third and previous dose is greater than 56 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the student's birthdate is less than 11 months with a 4 day tolerance, and</li> <li>• the difference between the fourth dose and the previous is greater than 56 days with a 4 day tolerance.</li> </ul>
<p><b>2 doses 12-14 months 1st shot</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives two dose of the Haemophilus influenza, type B (Hib) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 14 months with a 4 day tolerance, and</li> <li>• the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.</li> </ul>
<p><b>1 dose 15 months 1st shot</b> <i>Compliant</i></p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose Haemophilus influenza, type B (Hib) or Hib 3-dose series (Hib-3) vaccine, and</li> <li>• the difference between the dose and the student's birthdate is greater than 15 months with a 4 day tolerance.</li> </ul>
<p><b>1 dose In Progress before 1 yr</b> <i>In Progress</i></p>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose Haemophilus influenza, type B (Hib) or Hib 3-dose series (Hib-3) vaccine,</li> <li>• the difference between the last dose and the student's birthdate is less than 11 months with a 1 day tolerance, and</li> <li>• the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>1 dose In Progress after 1 yr</b> <i>In Progress</i>	Students are considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one dose Haemophilus influenza, type B (Hib) or Hib 3-dose series (Hib-3) vaccine,</li> <li>the difference between the last dose and the student's birthdate is greater than 12 months with a 0 (zero) day tolerance, and</li> <li>the difference between the last dose and the effective date is less than 56 days with a 0 (zero) day tolerance.</li> </ul>
