## Consecutive Absence Report - Minimum Percent Absent per Day Field (SIS-159696)

### **[Enhancement]**

A new Minimum Percent Absent Per Day field has been added to the Consecutive Absence Report editor. This field allows the entry of a value between 1 and 100 that correlates to the percent of a day a student is absent - 100% means student was absent for every minute of the day, 50% means the student was absent for at least half of the minutes in the day, etc.
