The CTE Student Fact Template reports information regarding student CTE course and course completion. Only one record per student per CIP Classification reports.

The file name for this extract is in the same format as other PIMS extracts: StateDistrictNumber\_ReportName\_Date/Time (example: 122091352\_CTE\_Student\_Fact\_201408280246).

## **Generate the CTE Student Fact Template**

- 1. Select **CTE Student Fact Template** from the **Extract Type** dropdown list.
- 2. Enter the **Effective Date** of the extract in *mmddyy* format or use the calendar icon to select a date.
- 3. Enter the **Prior Reporting Date** of the extract in *mmddyy* format or use the calendar icon to select a date.
- 4. Select the **Format** of the extract.
- 5. If desired, select an existing **Ad hoc Filter** from which to report students. Only those students included in the filter and who meet the reporting population are included in the extract.
- 6. Select the desired Grades to include in the report.
- 7. Select the appropriate Calendar(s) from which to include data on the extract.
- 8. Click the **Generate Extract** button or the **Submit to Batch** button, if available. The extract displays in the selected format.
