Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Kansas State Department of Health and Environment.

## General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are counted as valid.
- Doses administered 5 days earlier than the minimum interval or age are not counted as valid doses and need to be repeated as age-appropriate.
- With the exception of Hepatitis B vaccine, immunizations given before 6 weeks of age are not considered valid.
- Half doses or reduced doses of a vaccine are not considered valid.

The following tables describe all Kansas immunization requirements per vaccine.

## DTap

Rule	Condition(s)
<b>Age 0-1 month</b> <b>No requirement</b>	<p>The student is not required to receive any doses of the DTaP/DTP vaccine if the student is less than 1 month old.</p>
<b>1 dose</b> <b>Age 2-3 months</b> <b>Compliant</b>	<p>The student is considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 2 months old but no older than 3 months old,</li> <li>• the student receives 1 dose of the Diphteria-tetanus-pertussis (DTaP/DTP) or Diphteria and Tetanus (DT) vaccine, and</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days, with a 4 day tolerance.</li> </ul>
<b>2 doses</b> <b>Age 4-5 months</b> <b>Compliant</b>	<p>The student is considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 4 months old but no older than 5 months old,</li> <li>• the student receives 2 doses of the Diphteria-tetanus-pertussis (DTaP/DTP) or Diphteria and Tetanus (DT) vaccine,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>
<b>3 doses</b> <b>Age 6-14 months</b> <b>Compliant</b>	<p>The student is considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 6 months old but no older than 14 months old,</li> <li>• the student receives 3 doses of the Diphteria-tetanus-pertussis (DTaP/DTP) or Diphteria and Tetanus (DT) vaccine,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance.</li> </ul>

Rule	Condition(s)
<b>4 doses Under 5 Compliant</b>	<p>The student is considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is no older than 59 months old,</li> <li>• the student receives 4 doses of the Diphteria-tetanus-pertussis (DTaP/DTP) or Diphteria and Tetanus (DT) vaccine,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the fourth dose and the previous is greater than 4 months with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and</li> <li>• the difference between the fourth dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>

<b>3 doses Compliant</b>	<p>The student is considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 84 months (7 years) old,</li> <li>• the student receives 3 doses of the Diphteria-tetanus-pertussis (DTaP/DTP), Diphteria and Tetanus (DT), Tetanus-diphteria (TD), or Tetanus, Diphteria, and Acellular Pertussis (Tdap) vaccine,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
