### Campus Parent & Campus Student - New Home Page (SIS-159639) **[Enhancement]**

A new home page has been created for Campus Parent users which replaces the former Today screen. This home page collects the most important items needing parents' and guardians' attention for all of their students and makes helpful information easily accessible.

The new home page displays a card for each student and summarizes information including:

- Food Service Balance
- Items needing attention such as documents, surveys, and course registration.
- Assignments due today and tomorrow
- Recent grades, scores, attendance events, and behavior events.

Click the gear icon next to the student cards to set the timeframe for data on the home page - today, yesterday & today, one week, or two weeks. This setting applies to all of a parent/guardian's students.

Click on a student's card to view more information for the student, including their local and state ID numbers, food service balance and barcode, today's schedule, and recent tasks and updates.

This individual student screen is also the new home page of Campus Student.

A new Display Option was added that determines whether the student's State ID displays. Note: this new home screen will require translation by districts if additional languages are desired.
