## Combine Person

## ID History Displaying Incorrect End Date When Record was Modified via Combined Person Tool (SIS-66618)

When two students were combined via the Combine Person tool, the kept student's ID History was incorrectly displaying an End Date of the current date and time of the server instead of the time in which the two records were combined. To address this issue, a new End Date field has been added to the following ID History tables:

- `dbo.studentNumberHistory`
- `dbo.StateIDHistory`
- `dbo.StaffNumberHistory`
- `dbo.StaffStateIDHistory`
- `dbo.edfiIDHistory`
- `dbo.otherIDHistory`

This change ensures anytime the following fields are modified or records are inserted via Combine Person, the proper End Date value is applied:

- Local Student Number
- Student State ID
- Local Staff Number
- Staff State ID
- EdFi ID
- NASIS ID

To address existing records in each of these ID History tables, the following data conversion was done:

- `dbo.studentNumberHistory`
  - Use the existing logic that determines what the End Date value for the UI and write this same value -1 to `dbo.studentNumberHistory.endDate`
- `dbo.StateIDHistory`
  - Use the existing logic that determines what the End Date value for the UI and write this same value -1 to `dbo.stateIDHistory.endDate`
- `dbo.StaffNumberHistory`
  - Use the existing logic that determines what the End Date value for the UI and write this same value -1 to `dbo.staffNumberHistory.endDate`
- `dbo.StaffStateIDHistory`
  - Use the existing logic that determines what the End Date value for the UI and write this same value -1 to `dbo.staffStateIDHistory.endDate`
- `dbo.edfiIDHistory`
  - Use the existing logic that determines what the End Date value for the UI and write this same value -1 to `dbo.edfiIDHistory.endDate`
- `dbo.otherIDHistory`
  - Use the existing logic that determines what the End Date value for the UI and write this same value -1 to `dbo.otherIDHistory.endDate`

- The counts for each day are summed, then divided by the number of days the section was offered from the start date of the section through the end date entered on the extract editor (or the end date of the section when it's earlier than the extract editor date). This value is then rounded down to the nearest whole number.
