Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Maryland Department of Health.

## General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval of age are counted as valid.
- Doses administered 5 days earlier than the minimum interval or age are not counted as valid doses and should be repeated as age appropriate.
- For compliance calculations, 4 weeks = 28 days
- Intervals of 4 or more months is calculated by calendar months.

## Additional Compliance Check

In Maryland, there is a scheduled task that runs nightly. This process determines whether a student is in compliance based on MD State rules. If the student meets the MD compliance rules, the box on the enrollment is checked. Once the checkbox is checked, it remains checked unless you manually clear the checkbox.

# Hepatitis B

Rule	Requirements
<b>1 dose 0-3 months</b> <b><i>Compliant</i></b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 3 months old and</li> <li>• the student receives 1 dose of the Hepatitis B (Hep B) vaccine.</li> </ul>
<b>2 doses 4-5 months</b> <b><i>Compliant</i></b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 4 months old and no older than 5 months old and</li> <li>• the student receives 2 doses of the Hepatitis B (Hep B) vaccine.</li> </ul>
<b>3 doses</b> <b><i>Compliant</i></b>	Student is considered compliant if the student has received 3 doses of the Hepatitis B (Hep B) vaccine.
<b>2 doses Hep-B Over 11 yrs</b> <b><i>Compliant</i></b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 132 months (11 years) old,</li> <li>• the student receives 2 doses of the Hepatitis B - 2 (Hep B - 2) vaccine, and</li> <li>• the difference between the second dose and the previous dose is greater than 4 months with a 4 day tolerance.</li> </ul>
<b>1 dose Hep B-2 Over 11 yrs</b> <b><i>In Progress</i></b>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 132 months (11 years) old,</li> <li>• the student receives 1 dose of the Hepatitis B - 2 (Hep B - 2) vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 4 months with a 0 (zero) day tolerance.</li> </ul>
<b>2 doses</b> <b><i>In-Progress</i></b>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives 2 doses of the Hepatitis B - 2 (Hep B - 2) vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 56 months with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>2 doses 112 days</b> <i>In-Progress</i>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 2 doses of the Hepatitis B (Hep B) vaccine, and</li> <li>the difference between the last dose and the first valid dose is less than 112 days with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose</b> <i>In Progress</i>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Hepatitis B (Hep B) vaccine, and</li> <li>the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<b>Default</b> <i>Not Compliant</i>	N/A

## DTaP

Rule	Compliance
<b>Age 0-1 months</b> <i>No Requirement</i>	N/A
<b>1 dose Age 2-3 months</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>student is at least 2 months old and no older than 3 months old and</li> <li>student receives 1 dose of the DT, DTaP/DTP, TD, or Tdap vaccine.</li> </ul>
<b>2 doses Age 4-5 months</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>student is at least 4 months old and no older than 5 months old and</li> <li>student receives 2 doses of the DT, DTaP/DTP, TD, or Tdap vaccine.</li> </ul>
<b>3 doses Age 6-14 months</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>student is at least 6 months old and no older than 14 months old and</li> <li>student receives 3 doses of the DT, DTaP/DTP, TD, or Tdap vaccine.</li> </ul>
<b>4 doses under 7</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>student is at no older than 83 months old and</li> <li>student receives 4 doses of the DT, DTaP/DTP, TD, or Tdap vaccine.</li> </ul>
<b>3 doses Over 7</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>student is at least 84 months old and</li> <li>student receives 3 doses of the DT, DTaP/DTP, TD, or Tdap vaccine.</li> </ul>

Rule	Compliance
<b>3 doses Under 7</b> <i>In-Progress</i>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 15 months old and no older than 83 months old and</li> <li>• student receives 3 doses of the DT, DTaP/DTP, TD, or Tdap vaccine.</li> </ul>
<b>2 doses</b> <i>In-Progress</i>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 6 months old,</li> <li>• student receives 2 doses of the DT, DTaP/DTP, TD, or Tdap vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose</b> <i>In-Progress</i>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student receives 1 dose of the DT, DTaP/DTP, TD, or Tdap vaccine and</li> <li>• the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

## Tdap

Rule	Compliance
<b>1 dose</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is in state grade: 07, 08, 09, 10, 11, or 12, and</li> <li>• student receives 1 dose of the Tdap vaccine.</li> </ul>
<b>No Doses</b> <i>Not Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is in state grade: 07, 08, 09, 10, 11, or 12, and</li> <li>• student has not received any doses of the Tdap vaccine.</li> </ul>
<b>Default</b> <i>No Requirement</i>	N/A

## Hib

Rule	Compliance
<b>Age 0-1 months</b> <b>No Requirement</b>	Students 1 month old and under are not required to receive any dose of the Hib vaccine.
<b>1 dose Age 2-3 months</b> <b>Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 2 months old but no older than 3 months old and</li> <li>• student receives 1 dose of the Hib vaccine.</li> </ul>
<b>2 dose Age 4-11 months</b> <b>Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 4 months old but no older than 11 months old and</li> <li>• student receives 2 doses of the Hib vaccine.</li> </ul>
<b>1 dose 4-11 months</b> <b>In Progress</b>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 4 months old but no older than 11 months old,</li> <li>• student receives 1 dose of the Hib vaccine and</li> <li>• the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose 12-59 months</b> <b>Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 12 months old but no older than 59 months old and</li> <li>• student receives 1 dose of the Hib vaccine.</li> </ul>
<b>No Doses under 60 months</b> <b>Non-Compliant</b>	Student is considered non-compliant if the student is under 60 month old and has not received any doses of the Hib vaccine.
<b>Default</b> <b>No Requirement</b>	N/A

## Pneumococcal (PPV)

Rule	Compliance
<b>Age 0-1 months</b> <b>No Requirement</b>	Students 1 month old and under are not required to receive any dose of the Pneumococcal (PPV) vaccine.
<b>1 dose required ages 2-3 months</b> <b>Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 2 months old but no older than 3 months old and</li> <li>• student receives 1 dose of the PPV vaccine.</li> </ul>

Rule	Compliance
<b>2 doses required age 4-23 months</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 4 months old but no older than 23 months old and</li> <li>• student receives 2 doses of the PPV vaccine.</li> </ul>
<b>1 dose Under 24 months</b> <i>In-Progress</i>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 4 months old but no older than 23 months old,</li> <li>• student receives 1 dose of the PPV vaccine, and</li> <li>• the difference between the dose and the effective date is less than 56 days with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose over 24 months</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 24 months old but no older than 59 months old and</li> <li>• student receives 1 dose of the PPV vaccine.</li> </ul>
<b>No Doses Under 5</b> <i>Non-compliant</i>	Student is considered non-compliant if the student is 59 months old or younger and has not received any doses of the PPV vaccine.
<b>Default</b> <i>No Requirement</i>	N/A

## Polio

Rule	Compliance
<b>Age 0-1 months</b> <i>No Requirement</i>	Students 1 month old and under are not required to receive any dose of the Polio (IPV/OPV) vaccine.
<b>Age 18+</b> <i>No Requirement</i>	Students 216 months (18 years) and older are not required to receive any dose of the Polio (IPV/OPV) vaccine.
<b>1 dose Age 2-3 months</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 2 months old but no older than 3 months old and</li> <li>• student receives 1 dose of the IPV, OPV or Polio (IPV/OPV) vaccine.</li> </ul>
<b>2 doses Age 4-5 months</b> <i>Compliant</i>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 4 months old but no older than 4 months old and</li> <li>• student receives 2 doses of the IPV, OPV or Polio (IPV/OPV) vaccine.</li> </ul>

Rule	Compliance
<b>3 doses</b> <b><i>Compliant</i></b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 6 months old and</li> <li>• student receives 3 doses of the IPV, OPV or Polio (IPV/OPV) vaccine.</li> </ul>
<b>2 doses</b> <b><i>In-Progress</i></b>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 6 months old,</li> <li>• student receives 2 doses of the IPV, OPV or Polio (IPV/OPV) vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>

<b>Age 0-11 months</b> <b><i>No Requirement</i></b>	Students 11 months old and under are not required to receive any dose of the MMR vaccine.
<b>1 dose 12-59 months</b> <b><i>Compliant</i></b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 12 months old but no older than 59 months old,</li> <li>• student receives 1 dose of the MMR or MMRV vaccine, and</li> <li>• the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>

Rule	Compliance
<b>1 dose 12-59 months M, M, R Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is at least 12 months old but no older than 59 months old,</li> <li>• student receives 1 dose of the Measles, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>• student receives 1 dose of the Rubella, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, OR</li> </ul> </li> <li>• student receives 1 dose of the Mumps, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul> </li> </ul>

<b>2 doses Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is in state grade: 91: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08,</li> <li>• student receives 2 doses of the Varicella or MMRV vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>• the difference between the second dose and the previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>2 dose 13 and older Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student receives 2 doses of the Varicella or MMRV vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 156 months (13 years) with a 4 day tolerance, and</li> <li>• the difference between the second dose and the previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>

Rule	Compliance
<b>1 dose In-Progress</b>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is in state grade: 91: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08,</li> <li>• student receives 1 dose of the Varicella or MMRV vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose 13 and older In-Progress</b>	Student is considered in progress if the following conditions have been met: <ul style="list-style-type: none"> <li>• student receives 1 dose of the Varicella or MMRV vaccine,</li> <li>• the difference between the last dose and the student's birthdate is greater than 156 months (13 years) with a 0 (zero) day tolerance, and</li> <li>• the difference between the last dose and the effective date is less than 28 days with a 0 (zero) day tolerance.</li> </ul>
<b>1 dose Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is in state grade: 95: Prekindergarten age 1, 96: Prekindergarten under age 1, 93: Prekindergarten age 3, 94: Prekindergarten age 2, 92: Prekindergarten age 4, <del>08</del>, 09, 10, 11, or 12,</li> <li>• student receives 1 dose of the Varicella or MMRV vaccine,</li> <li>• the difference between the last dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is less than 155 months with a 0 (zero) day tolerance.</li> </ul>
<b>Default Non-compliant</b>	N/A

## Meningococcal (MCV4)

Rule	Compliance
<b>1 dose Compliant</b>	Student is considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is in state grade: 07, 08, 09, 10, 11, or 12, and</li> <li>• the student receives 1 dose of the Meningococcal (MCV4) vaccine.</li> </ul>

Rule	Compliance
<b>No Doses</b> <b><i>Non-compliant</i></b>	Student is considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• student is in state grade: 07, 08, 09, 10, 11, or 12, and</li> <li>• the student has not received any doses of the Meningococcal (MCV4) vaccine.</li> </ul>
<b>Default</b> <b><i>No Requirement</i></b>	N/A
