Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Minnesota State Department of Health.

## General Compliance Rules

- There is a 4 day grace period for deadlines of a dose.
- Doses of Varicella and MMR must be given on the same day, or at least 28 days apart.
- The rules for MMR and Varicella are hard-coded for Minnesota districts, meaning that changes cannot be made to the rules for these two vaccines.

## Immunization Rules

The following tables describe all Minnesota immunization requirements per vaccine.

### Hepatitis B

Requirement	Rule
<b>In Process</b>	Students are considered <i>In Process</i> when they are not compliant and: <ul style="list-style-type: none"> <li>• had their most recent dose within the past 4 weeks or,</li> <li>• have had 2 doses with their most recent dose within the past 8 weeks.</li> </ul>

Requirement	Rule
<b>3 doses</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 2 doses of the Hepatitis B vaccine,</li> <li>the difference between the second and previous dose is greater than or equal to 28 days with a 4 day tolerance,</li> <li>the difference between the third and previous dose is greater than or equal to 56 days with a 4 day tolerance, and</li> <li>the difference between the third dose and the first valid dose is greater than 112 days with a 4 day tolerance.</li> </ul>
<b>2 dose combo 11 and up</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 2 doses of the Hepatitis B 2 (HepB-2) vaccine,</li> <li>the student is at least 132 months (11 years) old, and</li> <li>the difference between the second and previous is greater than or equal to 28 days with a 4 day tolerance.</li> </ul>
<b>1 dose</b> <i>In Grace Period</i>	Students are in grace period when they receive 1 dose Hepatitis B (Hep B) OR Hepatitis B 2 (HepB-2) vaccine and the difference between the last dose and the effective date is less than 28 days, with a 0 (zero) day tolerance.
<b>2 doses</b> <i>In Grace Period</i>	Students are in grace period when they receive 2 doses Hepatitis B (Hep B) vaccine and the difference between the last dose and the effective date is less than 56 days, with a 0 (zero) day tolerance.

## DTaP

Rule	Requirements
<b>under 3 months</b>	Students under 3 months old are not required to receive any doses of the DTaP vaccine.
<b>under 5 months</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>student is 4 months old and younger, and</li> <li>the student receives one dose of the DT, DTaP/DTP, Td, or Tdap vaccine.</li> </ul>
<b>under 7 months</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>student is 6 months old and younger, and</li> <li>the student receives two doses of the DT, DTaP/DTP, Td, or Tdap vaccine.</li> </ul>

# Tdap

These rules apply to students in grades 7-12:

Rule	Requirements
<b>1 dose</b> <i>Compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 84 months (7 years) old,</li> <li>the student receives 1 dose of the Tetanus, Diphtheria and Acellular Pertussis (Tdap) vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
<b>7-12 No Tdap</b> <i>Non-compliant</i>	Students are considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 84 months (7 years) old, and</li> <li>the student does not receive any doses of the Tetanus, Diphtheria and Acellular Pertussis (Tdap) vaccine.</li> </ul>
<b>Default</b> <i>Non-Compliant</i>	Student is considered non-compliant when they are in state grade 07, 08, 09, 10, 11, or 12 and have not received any doses of the Tetanus, Diphtheria and Acellular Pertussis (Tdap) vaccine.

# Polio

Rule	Requirements
<b>Age 18 and older</b> <i>No Requirement</i>	Students age 216 months (18 years) old are not required to receive any doses of the Polio vaccine.
