This is a .csv file that includes each of the new and updated translation terms.</li><li>Enter the language code for each term in the LanguageCode column. Language codes can be found in either of the locations below:<ul style="list-style-type: none"><li>Classic Look: Index&gt; System Administration&gt; Data Utilities&gt; Languages/Translations</li><li>New Look: Index&gt; System Settings&gt; Portal Preferences&gt; Translation Language Setup</li></ul></li><li>Enter the translations within the TranslatedText column.</li><li>Save .csv to be uploaded when your district updates to Campus .2323.</li></ul>

The E-Signature has changed in that it no longer requires a PIN to be verified. If the E-Signature checkbox is selected, the parent/guardian will be required to sign electronically. If unchecked, the parent/guardian will only be required to complete the Authorization statement. More details to come with release information.</p>
<input type="checkbox"/>	2	<p>Upload the updated Infinite Campus-FRAM Online Application New &amp; Updated Translations:</p> <ol style="list-style-type: none"><li>1. Navigate to System Admin &gt; Data Utilities &gt; Languages/Translations.</li><li>2. Select the Translations tab.</li><li>3. Choose the language folder from Campus Parent/Student where the translations will be uploaded.</li><li>4.
