The primary nighttime residence is the basis for identifying homeless children and youth.

Description	Definition
Shelters	Homeless primary night time residence is a shelter and student is <u>not</u> served with McKinney-Vento (homeless) grant funds.
Doubled Up	Homeless primary night time residence is doubled-up (sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason) and student is not served with McKinney-Vento (homeless) grant funds.
Unsheltered	Homeless primary night time residence is unsheltered (e.g., cars, parks, campgrounds, abandoned buildings, substandard or inadequate housing, etc.) and student is not served with McKinney-Vento (homeless) grant funds.
Hotels/Motels	Homeless primary night time residence is a hotel or motel and student is not served with McKinney-Vento (homeless) grant funds.
Other	Homeless primary night time residence is another option not listed.
