Tool Search: Transcript

A transcript is a historical record of a student's performance in a course. The information printed on the transcript can vary from district to district depending on district preferences. Each district records grading information that students receive on transcripts and report cards. Grading information is connected to the course schedule of a student. Much of the data that appears in the Transcripts tool is auto-populated from other areas of the software. Users may change the value of these fields within Transcripts. However, be aware that making a change here, does NOT change the value of the originating field. For this reason, modifying posted Transcript records may cause discrepancies in records.
