Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Virginia State Department of Education.

# **General Compliance**

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are be counted as valid.
- Doses administered 5 days earlier than the minimum interval or age are not be counted as valid doses and must be repeated as age-appropriate.
- Half doses or reduced doses of a vaccine are not considered valid.

#### **Immunization Rules**

The following tables describe Virginia immunization requirements per vaccine.
