The Consolidated Student ID File import allows the importing of Student State IDs. This file generates for the entire district for the School Year in the Campus toolbar. This requires a match on the student's Person ID, Name, Gender and Date of Birth.

Consolidated Student ID (SSID) / Unique Staff Identifier (USID) - Imports Consolidated Student ID (SSID): This tool will import data from the state's Secure Student Identifier (SSD) system. If a student's Person DL, Last Name, First Name, Middle hinia, Gender, and Date of Birth are an exact match; student state IDs will be imported. If values do not match exactly Student State ID will not be imported and an error file will be generated. Unique Staff Identifier (USID): This tool will import data from the state's unique staff Identifier (USID) system. If a staff's Person DL Last Name, First Name, Middle Initial, Gender, applicable state race, and Date of Birth are an exact match; staff state IDs will be imported. If values do not match exactly Staff State ID will not be Inoproted and an error file will be

This is a two-fold process:

- 1. Generate the Consolidated Student ID Extract to find the students who need the SSID. This is then sent to the state.
- 2. Once the SSIDs have been assigned, use the Import to assign the SSIDs to the students.

Import Logic

When a match in the Import file is found with data that is an exact match for all required fields in Campus already, but that record already contains a state ID, **the new state ID IMPORTS and OVERWRITES the existing value**.

State IDs are NOT IMPORTED in the following situations:

- When a matching Person ID is not found.
- When a matching Birth Date is not found.
- When a matching First Name, Middle Initial, Last Name and Gender is not found (Protected



Identity Information is not marked on the Report Editor).

- When a matching Legal First Name, Legal Middle Initial, Legal Last Name and Legal Gender is not found (Protected Identity Information is marked on the Report Editor).
- When the import file is not found on the server.
- When the following fields are not populated:
 - Staff State ID
 - Person ID
 - First Name
 - Last Name
 - Gender
 - Birth Date

A header row is expected on the file. When the first row of the file contains student data, it is ignored.

Import Editor

Field	Description
Import	Indicates which file is being imported.
Protected Identity	When marked, validations are run against the Protected Identity Information fields (Legal Last Name, Legal First Name, Legal Gender fields). When not marked, the student's active identity information that displays on their Demographics record is used for validation.

Generate the Report

- 1. Select Consolidated Student ID (SSID) from the Import dropdown list.
- 2. Mark the **Protected Identity** checkbox to validate student information against the Legal Name and Gender fields.
- 3. Browse for the file to import. When found, click the Upload button.

A Results file displays with a list of errors or warnings that need to be reviewed. Also noted is the total number of records that were inserted and the total number of records that were changed.

Import Validations

Condition	Result	Message
