**D Records:** Multiple records can report when multiple resolutions are associated with the offender of the state coded event.

- Multiple records can report for each Behavioral Intervention or Instructional Support's on a state coded resolution.
- A record reports for each state coded resolution associated with state coded event resolution information associated with the offender reporting in C record.
- A record reports for each Behavioral Intervention Code associated with the state coded resolution.
- A record reports for each Instructional Support Code associated with state coded resolution.
- A unique record is reported per Local Event ID, State Testing ID, Behavior Code, Behavioral Intervention Code, Instructional Support Code, Disciplinary Sanction Code, and Alternative Education Setting.
- **Note:** There must be a state coded event and state coded resolution in order to report. However, a record is reported when the resolution mapped to the state resolution = NONE.
