Action	Trigger
Post	When an IEP is created and overlaps the configured year and the student has an enrollment in the configured year. <ul style="list-style-type: none"> Do not send a record if enrollment is in a calendar marked as Exclude. Do not send a record if enrollment is in a school marked as Exclude. The Print Format of the IEP can be 'nmGiftedPlan'. Do not send a record if enrollment is marked as No Show. Do not send a record if enrollment is in a calendar marked as Summer School. Do not send a record if enrollment is in a Grade marked as State Exclude. Do not send a record if Primary Area of Exceptionality = '3: Gifted Only'.
