## Object Triggering Logic

Action	Business Rules
POST	<p>Reports a record when the student has a locked Initial Evaluation <b>OR</b> a locked IEP that overlaps an enrollment and the configured year.</p> <ul style="list-style-type: none"> <li>• Do not report a record if the any of the following exclusions are present: <ul style="list-style-type: none"> <li>◦ Enrollment State Exclude</li> <li>◦ Enrollment No Show</li> <li>◦ Enrollment Grade Exclude from State Reporting</li> <li>◦ Calendar Exclude</li> <li>◦ School Exclude</li> </ul> </li> <li>• Only information from <b>locked</b> plans and evaluations will be reported.</li> <li>• Only information from Initial Evaluations is considered. <ul style="list-style-type: none"> <li>◦ The only exception to this is lastEvaluationDate.</li> </ul> </li> </ul>
DELETE / POST PUT	<p>A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.</p> <ul style="list-style-type: none"> <li>• Changes to the following elements on the Evaluation / IEP: <ul style="list-style-type: none"> <li>◦ Locked Status</li> </ul> </li> </ul>
DELETE	<ul style="list-style-type: none"> <li>• When the Evaluation is unlocked.</li> <li>• When the IEP is unlocked.</li> <li>• When the Evaluation is deleted.</li> <li>• When the IEP is deleted.</li> <li>• When the student no longer has any reportable enrollments.</li> <li>• When the student is excluded in some way.</li> </ul>

## State Reporting Editors and Fields
