## Object Triggering Logic

This table describes the logic for triggering the syncing of this object.

A Staff Education Organization Assignment Association or a Staff Education Organization Employment Association record must be sent in order to see / access a Staff Record in the ODS. This is the security protocol set by Ed-Fi. Staff records are not visible until they are associated to a District or School through the Staff Education Organization Assignment Association or Staff Education Organization Employment Association records.

Action	Trigger
Post	<p>When a person has a District Employment or District Assignment record that overlaps the configured year and they have an Ed-Fi ID.</p> <p>Do NOT report a record if any of the following scenarios are true:</p> <ol style="list-style-type: none"> <li>1. There is not an Ed-Fi ID for the staff person.</li> <li>2. The staff records are not active based on the Scope Year logic listed below.</li> <li>3. If the record is being triggered from a District Assignment record and it is marked as Exclude.</li> <li>4. If the record is being triggered from a District Assignment record and the School is marked as Exclude.</li> </ol>

Action	Trigger
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed-Fi Identity Mapping table.
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.
