Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	 When a section is created and saved. Section Placement is required in order for the section to send. One record reports for each Section and Term Type combination. Does not send records when the Calendar Exclude check box is checked. Does not send records when the course is marked inactive or State Exclude. Does not send when the School Exclude check box is checked. When the Secondary School field is populated, reports information from this new school as an override to the current school.
Post	When Section Placement is changed and saved on a section.
Post	When the Local Course Number or Term type Override is changed.
Put	 When any fields listed below are changed: When the local course name or SCED Seq Number is changed and saved on the Course editor. When the Instructional Setting is changed and saved on a section. When the Credit field is changed and saved on a Grading Task assigned to the course. When the Teacher Number field is changed and saved on a Rule 18 student Transcript.
Delete	When a section is deleted.
Delete	When Section Placement is changed or removed and saved on a section.
Delete	When the Local Course Number or Term type Override is changed.

Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	When a resource is toggled to OFF after data has sent, all sent data remains in the ODS but no new data sends.
Delete	When a resource is toggled to OFF after data has sent and an action is performed that would trigger a delete, that data remains in the ODS until a resync is done.
Resync	When a record is in the Ed-Fi Identity Mapping table and not in the ODS, it is deleted from the Ed-Fi Identity Mapping table
Resync	When a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it is deleted from the ODS.
Resync	When a mapping is changed in Resource Preferences, a resync needs to be done to reflect the changes.

Natural Key Changes, Cascading Updates, and Deletes Logic

This table describes the Natural Key Changes/Cascading Updates and Deletes logic of this object.

Action	Trigger
Post/Delete	 Natural Key Changes: When the School ID changes, all data remains under the old number and a resync needs to be completed to populate data under the new number. The delete tool does not need to be used to remove all data from the old School ID.
Post/Delete	When any of the following changes in the Course Offerings resource: • Local Course Code • Session Name
Post/Delete	When the natural key changes, all dependent data is deleted/posted.
Dependent Resources	Staff Section Associations, Student Section Associations, Student Section Attendance Events, Grades
