Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	<p>The student must have a Student School Association record in the configured year and meet the following EL record criteria:</p> <ul style="list-style-type: none"> The student has an EL Program Status of EL. Only one EL Services record reports per descriptor code. When there are multiple EL Services records assigned to the same descriptor code, the most recent record that is active in the configured year reports. The student has an EL Program Status of Exited EL and the First Year Monitoring or Second Year Monitoring dates overlap a configured year. Today's date is used to determine their status. The Program Exit date is used as the start date and the First Year Monitoring date as the end date to determine the student's status. A student marked as Redesignated English reports until the student is no longer in the district. The day after the First Year Monitoring date is used as the start date and the Second Year Monitoring date as the end date to determine the student's status. Does not send a record when the student's Second Year Monitoring date is before the configured year. Does not send a record when enrollment is in a calendar marked as Exclude. Does not send a record when enrollment is in a school marked as Exclude. Does not send a record when enrollment is marked as No Show.
Delete/Post	<p>When any field part of the natural key is changed:</p> <ul style="list-style-type: none"> Identified Date
Put	<p>When any field not part of the natural key is changed:</p> <ul style="list-style-type: none"> End Date englishLanguageProficiencyAssessments languageInstructionProgramServices
Delete	All enrollments are deleted for a student.
Delete	When the student's enrollment is marked as No Show.
Delete	When the student's EL record is no longer eligible to report based on Identified Date, Exit Date or EL Status.

School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	When a resource is toggled to OFF after data has sent, all sent data remains in the ODS but no new data sends.
Resync	When a record is in the Ed-Fi Identity Mapping table and not in the ODS, it is deleted from the Ed-Fi Identity Mapping table.
Resync	When a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it is deleted from the ODS.
Resync	When a mapping is changed in Resource Preferences, a resync needs to be done to reflect the changes.

Post/Delete	<p>Natural Key changes:</p> <ul style="list-style-type: none"> • LEA Reference - District Numbers cannot change after data has been sent. When a district number changes, an Ed-Fi error is expected and this change would not be supported. • When an Ed-Fi ID changes, a delete/post occurs with the cascading deletes from the Ed-Fi ID Change triggers. • When the Program Name or Program Type Descriptor mapping changes and a resync is completed. • When the Identified Date of the EL program record changes.
Delete	Cascading Deletes: N/A there are no dependent resources.

Scope Year Logic

Business Rules
The record sends to any year the EL record overlaps with when the student has an enrollment in that year.
Data only sends for the years that have valid configuration.
