Relationship Associations are reported from the Enrollment and locked IEPs. This is to identify any relationships a student may have with an organization outside the enrollment.

This resource is only available for Public Only configurations and the 2022-23 school year and later.

### **Object Triggering Logic**

The tables below describe the logic for triggering syncing of this object. Expand one of the areas below to see full requirements:

Action	Trigger
Post	When an Eligibility Report Eval with an Evaluation Type = Initial is created and saved for a student who has an enrollment record in the config year with 'Eval Only Student' is checked.  • The Consent Date of the locked Eligibility Report Eval must overlap the enrollment.  • If the student has an enrollment marked as State Exclude or WISE Exclude and the 'Eval Only Student' is checked, report a record  Note: If neither State or WISE Exclude are checked, a Student School  Associations resource will send.  • If the Ed-Fi Configuration Profile is Choice OR Choice + Private Opt In, do not send a record.  • Do not send a student record for an enrollment that is marked as State Exclude or WISE Exclude UNLESS the 'Eval Only Student' checkbox is checked.  • If the enrollment record is marked State Exclude or WISE Exclude, but 'Eval Only Student' is checked, send a Student Special Education Program Eligibility Associations record along with a Student Education Organization Responsibility Associations record.  Note: This is for students who are technically not enrolled or attending the district. This includes homeschooled, private school students, and 0-3 yr old students who are just being evaluated.  • A check will first be run to see if the student record exists in ODS before POST.  1. If the student does not exist, send a student record only when they have either or both of the following and Eval Only Student = checked:  1. State Exclude 2. WISE Exclude 2. WISE Exclude 2. If student record already exists in the ODS, POST SEORA the record.  • Do not send a record if the enrollment record is marked as State Exclude or Summer School or if the calendar is in a School marked Exclude.
Post	When an Enrollment record is added for a student in the config year with 'Eval Only Student' checked and does not have a locked Initial Eligibility Report Eval.  Note: Record will send with a beginDate based on Enrollment Start Date instead of Consent Date from the Eval.
Post/Delete	When a locked Eligibility Report Eval is edited and re-locked with a change to any of the fields not part of the natural key.
Post/Delete	When a School Override is set on Enrollment.
Delete	When an Eligibility Report Eval is deleted for a student.
Delete	When an Eligibility Report Eval is unlocked for a student.

Delete	<ul> <li>When an enrollment is deleted or the enrollment is marked No Show or the 'Eval Only Student' is unchecked:</li> <li>DELETE on /studentEducationOrganizationResponsibilityAssociation</li></ul>
Delete	If the Eligibility Report Eval Consent Date or the Enrollment Start or End Dates have been updated so the locked Eval and Enrollment no longer overlap, delete the record if one was created.

### **Scope Year**

#### **Business Rules**

When a new Eligibility Report Eval is created and locked, the record will report in the Scope Year that the Consent Date overlaps with:

- The Consent Date of the locked Eligibility Report Eval must be on or before the School Year End Date.
- Data will only send for the years that have valid configuration.

When the record is triggered from enrollments with 'Eval Only Student' checked, the record will send to the scope year for the school year the enrollment is associated with:

• Data will only send for the years that have valid configuration.
