Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the New York State Department of Health.

## General Compliance

Vaccine doses administered less than or equal to 4 days before the minimum interval or age are counted as valid.

Doses administered 5 days earlier than the minimum interval or age are not counted as valid doses and are repeated as age-appropriate.

The New York Polio vaccine rules allow for a grandfather rule. The grandfather rule identifies a student as compliant if they have not had a dose after 48 months if the doses were all given before 08/07/2010. This date represents when the ACIP rules changed to make the 48 months dose a required dose. To accommodate the grandfather rule, a field called "Last Dose Date" is available on the Immunization Rule Detail Page. This field allows Campus to compare the date of a student's last dose to a specific date in time, not merely against Effective Date or Birth Date.

Students enrolled in grade-less classes should meet the immunization requirements of the grades for which they are age equivalent:

- PK = 4-5 years
- KG = 4-6 years
- 1st = 6-7 years
- 2nd = 7-8 years
- 3rd = 8-9 years

- 4th = 9-10 years
- 5th = 10-11 years
- 6th = 11-12 years
- 7th = 12-13 years
- 8th = 13-14 years
- 9th = 14-15 years
- 10th = 15-16 years
- 11th = 16-17 years
- 12th = 17-18 years

## Hepatitis B

Rule	Condition
<b>18+ No Requirement</b> <i>No Requirement</i>	Students 216 months (18 years) old or older are not required to receive any doses of the Hepatitis B vaccine.
<b>3 dose Compliant</b>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives 3 doses of the Hepatitis B (Hep B) or Hep-B 3 dose vaccine,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the last dose and second valid dose is greater than 56 days with a 4 day tolerance,</li> <li>• the difference between the last dose and first valid dose is greater than 112 days with a 4 day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 168 days with a 4 day tolerance.</li> </ul>
<b>2 Adult doses Compliant</b>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student receives 2 doses of the Hepatitis B (Hep B) vaccine, and</li> <li>• the difference between the second dose and the previous is greater than 4 months with a 4 day tolerance.</li> </ul>

<b>2 doses IP</b> <i>In Progress</i>	<p>Students are considered in progress if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives 2 doses of the Hepatitis B (Hep B) or Hep-B 3 dose vaccine, and</li> <li>the difference between last dose and effective date is less than 56 days with a 0 (zero) day tolerance.</li> </ul>

<b>4 doses PK Compliant</b>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grades PS: Preschool, PKH: Prekindergarten Half Day, or PKF: Prekindergarten Full Day, and</li> <li>the student receives 4 doses of the DTaP/DTP or Tdap vaccine.</li> </ul>
<b>4 doses K-5 Compliant</b>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grades KH: Half Day Kindergarten, KF: Full Day Kindergarten, 01, 02, 03, 04, or 05,</li> <li>the student receives 4 doses of the DTaP/DTP or Tdap vaccine,</li> <li>the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the previous is greater than 4 months with a 4 day tolerance.</li> </ul>
<b>3 doses Compliant</b>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grades 06, 07, 08, or 09,</li> <li>the student receives 3 doses of the DT, DTaP/DTP, Td, or Tdap vaccine,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance.</li> </ul>
<b>3 doses 10-12 Compliant</b>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grades 10, 11, or 12, and</li> <li>the student receives 3 doses of the DT, DTaP/DTP, Td, or Tdap vaccine.</li> </ul>

<b>3 doses</b> <b>Catch-up K-5</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grades KH: Half Day Kindergarten, KF: Full Day Kindergarten, 01, 02, 03, 04, or 05,</li> <li>the student receives 3 doses of the DTaP/DTP or Tdap vaccine,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the last dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>

<b>Grade PK - 5th</b> <i>No Requirement</i>	<p>Students in state grades PS, PKH, PKF, KH, KF, 01, 02, 03, 04, 05 are not required to receive any doses of the Tetanus, Diphteria and Acellular Pertussis (Tdap) vaccine.</p>
<b>Grade 6 Age 10 and younger</b> <i>No Requirement</i>	<p>Students 119 months old or younger in state grade 06 are not required to receive any doses of the Tetanus, Diphteria and Acellular Pertussis (Tdap) vaccine.</p>
<b>18+ No Requirement</b> <i>No Requirement</i>	<p>Students 216 months (18 years) old or older are not required to receive any doses of the Tetanus, Diphteria and Acellular Pertussis (Tdap) vaccine.</p>

<b>Grade 9-12 Compliant</b>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grades 09, 10, 11, or 12,</li> <li>• the student receives 1 dose of the Tdap or Diphteria-tetanus-pertussis (DTaP/DTP) vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
<b>Age No Requirements</b>	<p>Students who are no older than 131 months old and in state grades 13, 14, GD are not required to receive any doses of the Tdap vaccine.</p>
<b>6th-12th Grade (Age) Compliant</b>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 132 months old,</li> <li>• the student is in state grades 13, 14, or GD,</li> <li>• the student receives 1 dose of the Diphteria-tetanus-pertussis (DTaP/DTP) vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 84 months with a 4 day tolerance.</li> </ul>
<b>6th-12th Grade Tdap (Age) Compliant</b>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 132 months old,</li> <li>• the student is in state grades 13, 14, GD,</li> <li>• the student receives 1 dose of the Tdap vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 120 months with a 4 day tolerance.</li> </ul>

<b>1 MMR PKH and PKF Compliant</b>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grades PKH: Prekindergarten Half Day, PKF: Prekindergarten Full Day, or PS: Preschool,</li> <li>the student receives 1 dose of the Measles-Mumps Rubella (MMR) or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>

<b>18+ No Requirement</b> <i>No Requirement</i>	<p>Students 216 months (18 years) old or older are not required to receive any doses of the Varicella vaccine.</p>
<b>Under 12 months</b> <i>No Requirement</i>	<p>Students 11 months old or younger are not required to receive any doses of the Measles-Mumps Rubella (MMR) or Measles-Mumps-Rubella-Varicella (MMRV) vaccine.</p>
