This will require districts to review their OLR Configurations and ensure that all of their radio buttons have updated literals. This is extremely important, as most districts have added a text field above their radio buttons to explain the button itself and make the radio button look required. With these new literals, districts will be able to make the radio buttons themselves required and have the required indicator appear for them. ([CDP-3353](#))
  - If you are unsure if you have any affected radio buttons in your OLR Configuration, please check out your OLR Information Center to see if there are any warnings related to your radio buttons.

  - All parents will need an email address listed to receive the email.
  - The parent that started the application will get all the GUIDs for the parents/guardians in the primary household, like before.
  - They must leave the (L)PARENT1(L), (L)PARENT2(L), (L)PARENT3(L),(L)PARENT4(L) in for all the emails to send out.
