Tool Search: Vaccines

Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the New Mexico department of Health.

## General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are counted as valid.
- The following doses are not counted as valid doses:
  - Doses administered 5 days earlier than the minimum interval or age.
  - With the exception of Hepatitis B vaccine, immunizations given before 6 weeks of age.
  - Half doses or reduced doses of a vaccine.

## DTaP

Rule	Requirements
<b>Age 0-1 months</b> <i>No Requirement</i>	Students 1 months old and younger are not required to receive any doses of the DTaP vaccine.

<p><b>1 dose by 4 months</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 1 month old but no older than 4 months, and</li> <li>• the student receives 1 dose of the following vaccines:               <ul style="list-style-type: none"> <li>◦ Diphtheria and Tetanus (DT),</li> <li>◦ Diphtheria-tetanus-pertussis, combined (DTaP, DTP),</li> <li>◦ Tetanus-diphtheria (Td), OR</li> <li>◦ Tetanus, Diphtheria and Acellular Pertussis (Tdap).</li> </ul> </li> </ul>
<p><b>2 doses by 6 months</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 4 months old but no older than 6 months, and</li> <li>• the student receives 2 doses of the following vaccines:               <ul style="list-style-type: none"> <li>◦ Diphtheria and Tetanus (DT),</li> <li>◦ Diphtheria-tetanus-pertussis, combined (DTaP, DTP),</li> <li>◦ Tetanus-diphtheria (Td), OR</li> <li>◦ Tetanus, Diphtheria and Acellular Pertussis (Tdap).</li> </ul> </li> </ul>
<p><b>3 doses by 47 months</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 6 months old but no older than 47 months, and</li> <li>• the student receives 3 doses of the following vaccines:               <ul style="list-style-type: none"> <li>◦ Diphtheria and Tetanus (DT),</li> <li>◦ Diphtheria-tetanus-pertussis, combined (DTaP, DTP),</li> <li>◦ Tetanus-diphtheria (Td), OR</li> <li>◦ Tetanus, Diphtheria and Acellular Pertussis (Tdap).</li> </ul> </li> </ul>
<p><b>4 doses</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 48 months old but no older than 59 months, and</li> <li>• the student receives 4 doses of the following vaccines:               <ul style="list-style-type: none"> <li>◦ Diphtheria and Tetanus (DT),</li> <li>◦ Diphtheria-tetanus-pertussis, combined (DTaP, DTP),</li> <li>◦ Tetanus-diphtheria (Td), OR</li> <li>◦ Tetanus, Diphtheria and Acellular Pertussis (Tdap).</li> </ul> </li> </ul>

Rule	Requirements
<b>5 doses K-12</b> <i>Compliant</i>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 60 months old,</li> <li>• the student receives 5 doses of the following vaccines:               <ul style="list-style-type: none"> <li>◦ Diphtheria and Tetanus (DT),</li> <li>◦ Diphtheria-tetanus-pertussis, combined (DTaP, DTP),</li> <li>◦ Tetanus-diphtheria (Td), OR</li> <li>◦ Tetanus, Diphtheria and Acellular Pertussis (Tdap), and</li> </ul> </li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>

<b>Default - Non-Compliant</b>	N/A

## Tdap

Rule	Requirements
<b>1 dose</b> <i>Compliant</i>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives one dose of the Tdap vaccine.</li> </ul>
<b>No doses</b> <i>Non-compliant</i>	<p>The student is considered non-compliant when they are in state grade: 06, 07, 08, 09, 10, 11, 12 and have not received and doses of the Tdap vaccine.</p>
<b>Default</b> <i>No Requirement</i>	N/A

## Hepatitis B

Rule	Requirements
<b>1 dose 0-4 months</b> <i>Compliant</i>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is no older than 4 months old, and</li> <li>the student receives 1 dose of the Hepatitis B vaccine.</li> </ul>

Rule	Requirements
<p><b>2 doses 4-6 months</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 4 months old, but no older than 5 months,</li> <li>• the student receives 2 doses of the Hepatitis B vaccine, and</li> <li>• the difference between the second dose and the previous is greater than or equal to 28 days with a 4 day tolerance.</li> </ul>
<p><b>3 doses</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives 3 doses of the Hepatitis B vaccine,</li> <li>• the difference between the second dose and the previous is greater than or equal to 28 days with a 4 day tolerance,</li> <li>• the difference between the last dose and the second valid dose is greater than or equal to 56 days with a 4 day tolerance,</li> <li>• the difference between the last dose and the first valid dose is greater than or equal to 112 days with a 4 day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 168 days with a 4 day tolerance.</li> </ul>
<p><b>2 doses Hep B-2 Over 11 yrs</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 132 months old,</li> <li>• the student receives 2 doses of the Hepatitis B - 2 doses (HepB-2) vaccine, and</li> <li>• the difference between the last dose and the previous is greater than or equal to 4 months with a 4 day tolerance.</li> </ul>
<p><b>1 dose Hep B-2 Over 11 yrs</b> <i>In Progress</i></p>	<p>The student is considered in progress when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 132 months old,</li> <li>• the student receives 1 dose of the Hepatitis B - 2 doses (HepB-2) vaccine, and</li> <li>• the difference between the dose and the effective date is less than or equal to 4 months.</li> </ul>
<p><b>2 doses</b> <i>In Progress</i></p>	<p>The student is considered in progress when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives 2 doses of the Hepatitis B vaccine, and</li> <li>• the difference between the last dose and the effective date is less than or equal to 56 days with a 0 (zero) day tolerance.</li> </ul>

Rule	Requirements
<b>1 dose</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Hepatitis B vaccine, and</li> <li>the difference between the dose and the effective date is less than or equal to 28 days with a 0 (zero) day tolerance.</li> </ul>

## MMR

Rule	Requirements
<b>2 doses</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives two doses of the MMR or MMRV vaccine, and</li> <li>the difference between the second to last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul>
<b>1 MMR 1 Measles</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives one for of the MMR or MMRV vaccine, and               <ul style="list-style-type: none"> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, AND</li> </ul> </li> <li>the student receives one for of the Measles vaccine, and               <ul style="list-style-type: none"> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul> </li> </ul>
<b>Default - Non-Compliant</b>	N/A

## Varicella

Rule	Requirements
<b>&lt; 1 year</b> <i>No Requirement</i>	Students 11 months old and younger are not required to receive any doses of the Varicella vaccine.

Rule	Requirements
<p><b>&lt; 4 years 1 Dose PK</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 12 months (1 year) old, and no older than 47 months old,</li> <li>• the student is in state grade: PK (PreKindergarten), 2U (0-2 Year old),</li> <li>• the student receives 1 dose of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul>
<p><b>&gt; 4 years 2 Dose PK</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 48 months (4 years) old,</li> <li>• the student is in state grade: PK (PreKindergarten),</li> <li>• the student receives 2 doses of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>• the difference between the last dose and the previous is greater than or equal to 28 days with a 4 day tolerance.</li> </ul>
<p><b>&gt; 4 years 1 Dose PK</b> <i>In Progress</i></p>	<p>The student is considered in progress when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 48 months (4 years) old,</li> <li>• the student is in state grade: PK (PreKindergarten),</li> <li>• the student receives 1 dose of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>• the difference between the last dose and the effective date is less than or equal to 3 months with a 1 day tolerance.</li> </ul>
<p><b>2 Doses K-12</b> <i>Compliant</i></p>	<p>The student is considered compliant when the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KN, KF, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, OS,</li> <li>• the student receives 2 doses of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>• the difference between the last dose and the previous is greater than or equal to 28 days with a 4 day tolerance.</li> </ul>



Rule	Requirements
<b>1 Dose K-12</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: KN, KF, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, OS,</li> <li>the student receives 1 dose of the Varicella or Measles-Mumps-Rubella-Varicella (MMRV) vaccine, and</li> <li>the difference between the last dose and the effective date is less than or equal to 3 months with a 1 day tolerance.</li> </ul>
<b>Default</b> <i>Non-Compliant</i>	N/A

## Polio

All OPV doses have an End Date of 04/01/2016.

Rule	Requirements
<b>4 doses</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 4 doses of the OPV, IPV, or IPV/OPV vaccine,</li> <li>the difference between fourth dose and previous is greater than or equal to 28 days with a 4 day tolerance,</li> <li>the difference between third dose and previous is greater than or equal to 28 days with a 4 day tolerance, and</li> <li>the difference between second dose and previous is greater than or equal to 28 days with a 4 day tolerance.</li> </ul>
<b>3 doses IPV</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 3 doses of the IPV or IPV/OPV vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>
<b>3 doses OPV</b> <i>Compliant</i>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 3 doses of the OPV or IPV/OPV vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>Default - Non-Compliant</b>	N/A

## Meningococcal MCV4

Rule	Requirements
<b>1 dose Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 1 dose of the Meningococcal (MCV4) vaccine, and</li> <li>the student is in state grade: 07.</li> </ul>
<b>1 dose Non-Compliant</b>	The student is considered non-compliant when they are in in state grade: 07 and have not received any doses of the Meningococcal vaccine.
<b>Default</b>	No Requirement

## Hepatitis A

Rule	Requirements
<b>&lt; 1 year No Requirement</b>	Students 11 months old and younger are not required to receive any doses of the Hepatitis A vaccine.
<b>1 dose Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 12 months (1 year) old, and no older than 47 months old, and</li> <li>the student receives 1 dose of the Hepatitis A vaccine.</li> </ul>
<b>2 doses Compliant</b>	The student is considered compliant when the following conditions have been met: <ul style="list-style-type: none"> <li>the student is at least 48 months (4 years) old,</li> <li>the student receives 2 doses of the Hepatitis A vaccine, and</li> <li>the difference between the second dose and the previous is greater than or equal to 6 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>1 dose</b> <i>In Progress</i>	The student is considered in progress when the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is at least 18 months old,</li> <li>• the student receives 1 dose of the Hepatitis A vaccine, and</li> <li>• the difference between the dose and the effective date is less than or equal to 6 months with a 1 day tolerance.</li> </ul>
<b>Default PK-1st</b> <i>Non-Compliant</i>	Students are considered non-compliant when they are in state grade: PK, KN, KF, 01, and have not received any doses of the Hepatitis A vaccine.
<b>Default 2-12</b> <i>No Requirement</i>	Students in state grade(s): 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12 are not required to receive any doses of the Hepatitis A vaccine.
