#### General Compliance | Immunization Rules

Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Wisconsin Department of Health Services.

# **General Compliance**

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are counted as valid.
- Doses administered 5 days earlier than the minimum interval or age are not counted as valid doses and must be repeated as age-appropriate.

The following rules are included for all vaccines (These rules do not apply to students who do not have a requirement for Tdap):

No doses first year In Process	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and have not received any doses of the vaccines listed below in the first year of the student's enrollment are considered in process.
1 dose first year In Process	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and have received one dose of the vaccines listed below in the first year of the student's enrollment are considered in process.



Rule	Condition
2 doses first year In Process	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre- Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10,
Not needed for MMR	11, 12, and have received two doses of the vaccines listed below in the first year of the student's enrollment are considered in process.
2 doses second year In Process	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and have received two doses of the vaccines listed below in the second year of the student's enrollment are considered in process.
KG Default In Process	Students in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre- Kindergarten and have received 1 dose of the vaccines listed below are considered in process.

#### **DTap**

Rule	Conditions
4 doses Compliant	Students are considered compliant when the following conditions have been met:  • the student is in state grade: 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and  • the student receives four doses of the DT, DTAP/DTP, Td, or Tdap vaccines.
4 doses PreK Compliant	Students are considered compliant when the following conditions have been met:  Students are considered compliant when the following conditions have been met:  • the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, and  • the student receives four doses of the DT, or DTAP/DTP vaccines.

#### **Polio**

3 doses PreK Compliant	Students are considered compliant when the following conditions have been met:  • the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, and  • the student receives three doses of the IPV, OPV, or IPV/OPV vaccines.
3 doses K-12 Compliant	Students are considered compliant when the following conditions have been met:  • the student receives three doses of the IPV, OPV, or IPV/OPV vaccines, and  • the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.
4 doses K-12 Compliant	Students are considered compliant when the following conditions have been met:  • the student receives four doses of the IPV, OPV, or IPV/OPV vaccines.

## **Measles Mumps Rubella MMR**

Rule	Condition
1 dose PreK Compliant	<ul> <li>Students are considered compliant when the following conditions have been met:</li> <li>the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten,</li> <li>the student receives one dose of the MMR or MMRV vaccines, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul>



Rule	Condition
1M, 1M, 1R PreK	Students are considered compliant when the following conditions have been met:
Compliant	<ul> <li>the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten,</li> <li>the student receives one dose of the Measles vaccine,</li> </ul>
	<ul> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR</li> <li>the student receives one dose of the Mumps,</li> </ul>
	<ul> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR</li> <li>the student receives one dose of the Rubella,</li> </ul>
	<ul> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul>
2 doses K-12 Compliant	Students are considered compliant when the following conditions have been met:
	<ul> <li>the student receives two doses of the MMR or MMRV vaccines, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.</li> </ul>
1MMR, 1M, 1M, 1R K-12	Students are considered compliant when the following conditions have been met:
Compliant	• the student is in state grade: K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre- Kindergarten,

Rule	Condition
2M, 2M, 2R, K-12 Compliant	Students are considered compliant when the following conditions have been met:  • the student receives two doses of the Measles vaccine,  • the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR  • the student receives two doses of the Mumps,  • the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance, OR  • the student receives two dose of the Rubella,  • the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4 day tolerance.

## **Hepatitis B**

Rule	Condition
3 doses Compliant	Students are considered compliant when the following conditions have been met:  • the student receives three doses of the Hepatitis B, Hepatitis B 2 Dose, or Hepatitis B 3 dose vaccines.
2 doses Compliant	Students are considered compliant when the following conditions have been met:  • the student receives two doses of the Hepatitis B 2 Dose vaccine.

#### **Varicella**

Rule	Condition
2 doses Compliant	<ul> <li>Students are considered compliant when the following conditions have been met:</li> <li>the student is in state grade: KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and</li> <li>the student receives two doses of the MMRV or Varicella vaccines.</li> </ul>

# **Tdap**

Rule	Condition
PK-5 Grade No Requirements	Students in state grade(s): K3: 3-yr-old KG, K4: 4-yr-old KG, PK: Pre-Kindergarten, KG: Kindergarten, 01, 02, 03, 04, 05, are not required to receive any doses of the Tdap vaccine.



Rule	Condition
1 Tdap grades 06-12 Compliant	Students are considered compliant when the following conditions have been met:  • the student is in state grade: 06, 07, 08, 09, 10, 11, 12, and  • the student receives one dose of the Tdap vaccine.
Within 5 years grades 06-12 Compliant	Students are considered compliant when the following conditions have been met:  • the student is in state grade: 06, 07, 08, 09, 10, 11, 12, and  • the student receives one dose of the DT, DTaP/DTP, Td, or Tdap vaccines, and  • the difference between the last dose and the student's grade 6 start date is less than or equal to 5 years with a 1 day tolerance.
<b>Default</b> <i>Behind Schedule</i>	Students are considered behind schedule when they are in state grade(s): 06, 07, 08, 09, 10, 11, 12, and have not received any doses of the Tdap vaccine.
