

The following information describes vaccine compliance rules as defined by the Arizona State Department of Health.

## General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are counted as valid.
- Doses administered 5 days before the minimum interval or age are be counted as valid doses and must be repeated as age-appropriate.

## Hepatitis B

The following vaccine dose requirements apply to students who **are not yet** enrolled in kindergarten or higher.

- 1 dose required for ages 0-3 months.
- 2 doses required for ages 4-11 months. The difference between the second dose and the first valid dose must be greater than or equal to 28 days and has 4 day tolerance.
- 3 doses required for ages 12 months and older, with the last does on or after 24 weeks of age.
  - The difference between the second dose and the first valid dose must be greater than or equal to 28 days and has 4 day tolerance.
  - The difference the last dose and the second valid dose must be greater than or equal to 56 days and has a 4 day tolerance.
  - The difference between the last dose and the first valid dose must be greater than or equal to 168 days and has a 4 day tolerance.
- 4 doses compliant for ages 12 months and older.
  - The difference between the second dose and the first valid dose must be greater than or equal to 28 days and has 4 day tolerance.
  - The difference the last dose and the second valid dose must be greater than or equal to 56 days and has a 4 day tolerance.
  - The difference between the last dose and the first valid dose must be greater than or equal to 112 days and has a 4 day tolerance.

The following vaccine dose requirements apply to students who **are** enrolled kindergarten or higher.

- 4 doses required for compliance
  - The difference between the second dose and the first valid dose must be greater than or equal to 28 days and has 4 day tolerance.
  - The difference the last dose and the second valid dose must be greater than or equal to 56 days and has a 4 day tolerance.
  - The difference between the last dose and the first valid dose must be greater than or equal to 112 days and has a 4 day tolerance.
- 3 doses required for compliance with the last dose on or after 24 weeks of age.
  - The difference between the second dose and the first valid dose must be greater than or equal to 28 days and has 4 day tolerance.
  - The difference the last dose and the second valid dose must be greater than or equal to 56 days and has a 4 day tolerance.
  - The difference between the last dose and the first valid dose must be greater than or equal to 168 days and has a 4 day tolerance.
- 2 doses of Adult Hepatitis B required for compliance.
  - The difference between the first dose and the student's birthdate is greater than 132

months with a 4 day tolerance.

- The difference between the second dose and the student's birthdate is less than 191 months with a 4 day tolerance.
- The difference between the second dose and the previous dose is greater than 4 months with a 4 day tolerance.

If a student is not compliant but has met the following requirements, that student is considered to be IN PROCESS.

- 1st dose within the last 2 months.
- 2nd dose within the last 4 months.
- 3rd dose within the last 4 months.

## DTaP

Rule	Requirements
<b>4 doses</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is in state grade: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, KG: Kindergarten,</li> <li>• the student receives 4 doses of the DT, DTaP/DTP, Td, or Tdap vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<b>6 doses under 7 years</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is no older than 83 months old,</li> <li>• the student is in state grade: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, KG: Kindergarten, and</li> <li>• the student receives 6 doses of the DT, DTaP/DTP, Td, or Tdap vaccine.</li> </ul>
<b>3 doses 7 years and up</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is at least 84 months (7 years) old,</li> <li>• the student is in state grade: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, KG: Kindergarten,</li> <li>• the student receives 3 doses of the DT, DTaP/DTP, Td, or Tdap vaccine, and</li> <li>• the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance.</li> </ul>
<b>1 doses K-12</b> <i>In Process</i>	Students are considered in process if the following conditions have been met: <ul style="list-style-type: none"> <li>• the student is in state grade: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, KG: Kindergarten,</li> <li>• the student receives 1 dose of the DT, DTaP/DTP, Td, or Tdap vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 28 days with a 1 day tolerance.</li> </ul>

Rule	Requirements
<b>2 doses K-12</b> <i>In Process</i>	<p>Students are considered in process if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, KG: Kindergarten,</li> <li>the student receives 2 doses of the DT, DTaP/DTP, Td, or Tdap vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 5 day tolerance</li> </ul>
<b>3 doses K-12</b> <i>In Process</i>	<p>Students are considered in process if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is in state grade: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, KG: Kindergarten,</li> <li>the student receives 3 doses of the DT, DTaP/DTP, Td, or Tdap vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 5 day tolerance.</li> </ul>
<b>Default K-12</b> <i>Non-compliant</i>	<p>Students in state grade: 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, KG: Kindergarten, who have not received any doses of the DT, DTaP/DTP, Td, or Tdap vaccine are considered non-compliant.</p>
<b>0-1 months</b> <i>No Requirement</i>	<p>Students 1 month old or less are not required to receive any doses of the DT, DTaP/DTP, Td, or Tdap vaccine.</p>
<b>2-3 months</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>student is at least 2 months and no older than 3 months old, and</li> <li>the student receives 1 dose of the DT, DTaP/DTP, Td, or Tdap vaccine.</li> </ul>
<b>4-5 months</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>student is at least 4 months and no older than 5 months old, and</li> <li>the student receives 2 doses of the DT, DTaP/DTP, Td, or Tdap vaccine.</li> </ul>
<b>6-14 months</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>student is at least 6 months and no older than 14 months old, and</li> <li>the student receives 3 dose of the DT, DTaP/DTP, Td, or Tdap vaccine.</li> </ul>
<b>15 months and older</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>student is at least 15 months old, and</li> <li>the student receives 4 dose of the DT, DTaP/DTP, Td, or Tdap vaccine.</li> </ul>
<b>1 dose</b> <i>In Process</i>	<p>Students are considered in process if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives 1 dose of the DT, DTaP/DTP, Td, or Tdap vaccine, and</li> <li>the difference between the dose and the effective date is less than 28 days with a 1 day tolerance.</li> </ul>

Rule	Requirements
<b>2 doses</b> <i>In Process</i>	Students are considered in process if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 2 dose of the DT, DTaP/DTP, Td, or Tdap vaccine, and</li> <li>the difference between the dose and the effective date is less than 5 months with a 1 day tolerance.</li> </ul>
<b>3 doses</b> <i>In Process</i>	Students are considered in process if the following conditions have been met: <ul style="list-style-type: none"> <li>the student receives 3 doses of the DT, DTaP/DTP, Td, or Tdap vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 5 day tolerance.</li> </ul>
<b>Default</b> <i>Non-compliant</i>	N/A

## Tdap

Rule	Requirements
<b>1 dose</b> <i>Compliant</i>	<ul style="list-style-type: none"> <li>Minimum age <math>\geq</math> 132 months (11 years)</li> <li>1 dose required of Tdap.</li> </ul>
<b>Age 11+ Booster</b> <i>No Requirement</i>	<ul style="list-style-type: none"> <li>Start date of 7/1/2014</li> <li>Minimum age <math>\geq</math> 132 months (11 years)</li> <li>1 dose required of DT, Tdap, Td, DTaP.</li> <li>Difference between the last dose and the effective date is less than 59 months, with a 1 day tolerance.</li> </ul>
<b>Default Age 11+</b> <i>Non-Compliant</i>	<ul style="list-style-type: none"> <li>No Requirement</li> <li>Minimum age <math>\geq</math> 132 months (11 years)</li> </ul>
<b>Default No Requirement</b>	No Requirement

## Hib

The following vaccine dose requirements apply to students who **are not yet** enrolled in kindergarten or higher.

- No requirements for ages 0-1 months
- 1 dose required for ages 2-3 months
- 2 doses required for ages 4-5 months

- 3 doses required for ages 6-14 months.
- 4 doses required for ages 15 months - 4 years.
- 1 dose required given on or after 15 months of age.
- 3 doses required with one dose given on or after 12 months of age
- No requirements for students 5 years and older.

The following vaccine dose requirements apply to students who **are** enrolled in kindergarten or higher.

- No requirements

If a student is not compliant but has met the following requirements, that student is considered to be IN PROCESS.

- Most recent dose was given within the last 2 months.

## MMR

The following vaccine dose requirements apply to students who **are not yet** enrolled in kindergarten or higher.

- No requirements for ages 0-11 months.
- 1 dose required for ages 12 months and older.

The following vaccine dose requirements apply to students who **are** enrolled in kindergarten or higher.

- 2 doses of MMR required with first dose on or after 12 months of age and
  - the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.
- 2 doses of Measles, Mumps, or Rubella vaccine with first dose on or after 12 months of age and
  - the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.

Students are considered In Progress if the following conditions have been met:

- the student is in state grade: 1, 10, 2, 3, 4, 5, 6, 7, 8, 9, 11, 12, KG,
- the student receives at least one dose of the MMR or MMRV vaccine, and
- the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.

## Varicella

Rule	Requirements
<b>0-11 months</b> <i>No Requirement</i>	Students 11 months old and younger are not required to receive any doses of the Varicella vaccine.

Rule	Requirements
<b>1 Dose Compliant</b>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives one dose of the Varicella or MMRV vaccine,</li> <li>• the difference between the dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and</li> <li>• the difference between the dose and the student's birthdate is less than 155 months with a 4 day tolerance.</li> </ul>
<b>2 Doses Compliant</b>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives two doses of the Varicella or MMRV vaccine,</li> <li>• the difference between the last dose and the student's birthdate is greater than 156 months with a 4 day tolerance, and</li> <li>• the difference between the second and previous dose is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>1 Dose In Process</b>	<p>Students are considered In Process if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student's birthdate is equal to or greater than 156 months</li> <li>• the student receives one dose of the Varicella or MMRV vaccine</li> <li>• the difference between the last dose and the effective date is less than or equal to 28 days with a 0 day tolerance</li> </ul>

## Polio

Rule	Requirements
<b>0-1 month No Requirement</b>	<p>Students 1 month old and younger are not required to receive any doses of the Polio vaccine.</p>
<b>2-3 months Compliant</b>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 2 months, but no older than 3 months old, and</li> <li>• the student receives 1 dose of the OPV (<i>End Date: 04/01/2016</i>), IPV, or IPV/OPV Polio vaccine.</li> </ul>
<b>4-11 months Compliant</b>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is at least 4 months, but no older than 11 months old, and</li> <li>• the student receives 2 doses of the OPV (<i>End Date: 04/01/2016</i>), IPV, or IPV/OPV Polio vaccine.</li> </ul>

Rule	Requirements
<b>3 doses</b> <b>Preschool</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade PS: Preschool,</li> <li>• the student receives 3 doses of the OPV (<i>End Date: 04/01/2016</i>), IPV, or IPV/OPV Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>4 doses</b> <b>before</b> <b>8/7/09</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student receives 4 doses of the OPV (<i>End Date: 04/01/2016</i>), IPV, or IPV/OPV Polio vaccine,</li> <li>• the student receives the last dose before 08/07/2009,</li> <li>• the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>• the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>• the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, and</li> <li>• the difference between the fourth dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul>
<b>3 doses</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>• the student is in state grade: KG: Kindergarten, 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12,</li> <li>• the student receives 3 doses of the OPV (<i>End Date: 04/01/2016</i>), IPV, or IPV/OPV Polio vaccine,</li> <li>• the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance, and</li> <li>• the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance.</li> </ul>

Rule	Requirements
<b>4 doses</b> <i>Compliant</i>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives 4 doses of the OPV (<i>End Date: 04/01/2016</i>), IPV, or IPV/OPV Polio vaccine,</li> <li>the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>
<b>1 dose</b> <i>In Process</i>	<p>Students are considered in process if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives 1 dose of the OPV (<i>End Date: 04/01/2016</i>), IPV, or IPV/OPV Polio vaccine, and</li> <li>the difference between the dose and the effective date is less than 28 days with a 1 day tolerance.</li> </ul>
<b>2 doses</b> <i>In Process</i>	<p>Students are considered in process if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student receives 2 doses of the OPV (<i>End Date: 04/01/2016</i>), IPV, or IPV/OPV Polio vaccine, and</li> <li>the difference between the last dose and the effective date is less than 5 months with a 1 day tolerance.</li> </ul>

## Meningococcal (MCV4)

Rule	Requirements
<b>1 Dose</b> <i>Compliant</i> Start Date 7/1/2014	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 132 months (11 years) of age, and</li> <li>the student receives 1 dose of the Meningococcal (MCV4) vaccine.</li> </ul>
<b>Default Age</b> <b>11+</b> <i>Non-Compliant</i> Start Date 7/1/2014	<p>Students are considered non-compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> <li>the student is at least 132 months (11 years) of age, and</li> <li>the student has NOT received any dose of the Meningococcal (MCV4) vaccine.</li> </ul>

## Hepatitis A

This vaccine is only required in Maricopa County.

- No requirements for ages 0-11 months
- No requirements for K-12
- 1 dose required for ages 12-17 months
- 2 doses required for ages 18 months and older with at least 6 months between doses. A 4 day tolerance applies to this rule.

If a student is not compliant but has received a dose within the last 6 months, that student is considered to be IN PROCESS.

---
