## Tool Search Term: Ed-FI

This resource represents the instances where a special education student was physically or mechanically restrained due to imminent serious physical harm to themselves or others, imminent serious property destruction or a combination of both imminent serious physical harm to themselves or others and imminent serious property destruction.

## Object Triggering Logic

The tables below describe the logic for triggering syncing of this object.

Action	Trigger
Post	<p>When an IEP is created and locked and overlaps the configured year and the student has an enrollment in the configured year.</p> <ul style="list-style-type: none"> <li>Do not send a record if enrollment is in a calendar marked as Exclude.</li> <li>Do not send a record if enrollment is in a school marked as Exclude.</li> <li>The Print Format of the IEP can be either the Campus Default IEP or a State IEP.</li> <li>Do not send a record if enrollment is marked as No Show.</li> </ul>
Delete/Post	When any field part of the natural key is changed.
Put	When any field not part of the natural key is changed.
Delete	When the locked IEP is deleted or unlocked for a student.
Delete	When all enrollments are deleted for a student.
Delete	If the student's enrollment is marked as No Show.
Delete	If the IEP no longer overlaps the configured year.
Delete	When the state reporting record is deleted.
Delete	If the state reporting record no longer overlaps the configured year.

## Scope Year

## Business Rules

IEP Plan start date through end date overlaps the Scope Year dates.

- If the School Year Start Date is NULL, 7/1/xxxx will be the default start date used.
- If the School Year End Date is NULL, 6/30/xxxx will be the default end date used.
- Data only sends for the years that have valid configuration.
