## Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	When a section is created and saved. <ul style="list-style-type: none"> <li>• Section Placement is required in order for the section to send.</li> <li>• One record reports for each Section and Term Type combination.</li> <li>• Does not send records when the Calendar Exclude checkbox is marked.</li> <li>• Does not send records when the course is marked inactive or Exclude from State Reporting.</li> <li>• Does not send when the School Exclude checkbox is marked.</li> <li>• Does not post a record when Exclude from State Reporting is marked on the Course.</li> </ul>
Post	When Section Placement is changed and saved on a section.
Post	When the Local Course Number or Term type Override is changed.
Put	When any fields listed below are changed: <ul style="list-style-type: none"> <li>• When the SCED Sequence Number is changed and saved on the Course editor.</li> <li>• When the Instructional Setting is changed and saved on a section.</li> <li>• When the Credit field is changed and saved on a Grading Task assigned to the course.</li> </ul>
Delete	When a section is deleted.
Delete	When Section Placement is changed or removed and saved on a section.
Delete	When the Local Course Number or Term Type Override is changed.

## School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	When a resource is toggled to OFF after data has sent, all sent data remains in the ODS but no new data is sent.
Delete	When a resource is toggled to OFF after data has sent and an action is performed that would trigger a delete, that data remains in the ODS until a resync is done.

Action	Trigger
Resync	When a record is in the Ed-Fi Identity Mapping table and not in the ODS, it is deleted from the Ed-Fi Identity Mapping table.
Resync	When a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it is deleted from the ODS.
Resync	When a mapping is changed in Resource Preferences, a resync is needed to reflect the changes.

## Natural Key Changes, Cascading Updates, and Deletes Logic

This table describes the Natural Key Changes/Cascading Updates and Deletes logic of this object.

Action	Trigger
Post/Delete	Natural Key Changes: <ul style="list-style-type: none"> <li>When the School ID changes, all data remains under the old number and a resync is needed to be completed to populate data under the new number. The delete tool would need to be used to remove all data from the old School ID.</li> </ul>
Post/Delete	When any of the following changes in the Course Offerings resource: <ul style="list-style-type: none"> <li>Local Course Code</li> <li>Session Name</li> </ul>
Post/Delete	When the natural key changes all dependent data is deleted/posted.
Dependent Resources	Staff Section Associations Student Section Associations Student Section Attendance Events Grades.
