# Combine Person

## Combine Person Triggering Error For Students with Store Purchases and Payment Method Being Modified (SIS-168416)

The Combine Person tool was generating an error and failing to combine two people if one or more of them had school store purchase on record. This issue was fixed.

The tool was also incorrectly modifying the payment method ID for payments and recurring payments attributed to the merged person, which could impact historical payment records and recurring payments established for the person. This issue was corrected. Now, when two people

who may have store purchase records are merged, historical purchase records are combined and existing payment methods for the kept person are left intact and unmodified.

We also updated the tool to add the CalculatedAbsenteeValues table to Attendance records.
