This occurred despite having the 'Use Proficiency Statuses' and 'EL' checkboxes marked on the test. The issue has been resolved and the EL-specific proficiency statuses display in the Proficiency Level drop list as expected.

## Custom

Custom Tool Setup – Updates Made to Allow Searching and Filtering of Editor Columns (SIS-173605) **[Enhancement]**

Users with many custom tools and URLs were unable to easily locate a specific tool or URL in the Custom Tool Editor due to pagination. To improve usability, each column in the [Custom Tool Editor](https://kb.infinitecampus.com/help/custom-tool-setup-custom-tool-setup) (<https://kb.infinitecampus.com/help/custom-tool-setup-custom-tool-setup>) now has a search bar and filtering options, allowing users to narrow displayed tools/URLs as they continue to type in a column's search field or by applying filtering criteria.

Classic Look Placement and URL Fields in Custom Tool Setup Updated to Prevent Truncation (SIS-173606) **[Enhancement]**

The new [Custom Tool Setup](https://kb.infinitecampus.com/help/custom-tool-setup-custom-tool-setup) (<https://kb.infinitecampus.com/help/custom-tool-setup-custom-tool-setup>) editor within Custom Tool Setup has been greatly widened to take up more screen, preventing the Classic Look Menu Placement and URL fields from truncating when viewing field data.

Custom Tool Setup – URL Field Required, Preventing the Creation of Custom Folders (SIS-174661)

[Custom Tool Setup](https://kb.infinitecampus.com/help/custom-tool-setup-custom-tool-setup) (<https://kb.infinitecampus.com/help/custom-tool-setup-custom-tool-setup>) was requiring the URL field be entered for custom URL Links, preventing users from creating URL Links without a URL which allowed them to be used as a folder to house other custom tools. This issue was corrected. The URL field is no longer required in custom URL Links and users can once again utilize URL Links to act as folders for other custom tools/URLs.

## Early Warning

Early Warning Tool Failing to Save Settings (SIS-174910)

The [Early Warning](https://kb.infinitecampus.com/help/early-warning) (<https://kb.infinitecampus.com/help/early-warning>) tool previously contained a Save button which caused user confusion due to its positioning and design. Additionally, the function tied to this button was broken by related changes to the interface. This button has been removed pending a redesign of this feature.

The redesign prioritizes accessibility by grouping similar items and simplifying on-screen choices.
