Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	<p>When an IEP is created and locked and overlaps the configured year and the student has an enrollment in the configured year OR the student has a State Reporting SPED record that overlaps the configured year and the student has an enrollment in the configured year.</p> <p>Do not send a record when:</p> <ul style="list-style-type: none"> • Enrollment is in a calendar marked as Exclude • Enrollment is in a school marked as Exclude • Enrollment is marked as No Show <p>The Print Format of the IEP can be either the Campus Default IEP or a State IEP</p>
Delete/Post/Put	<p>When any field part of the natural key is changed:</p> <ul style="list-style-type: none"> • IEP Start Date <p>When any field not part of the natural key is changed</p> <ul style="list-style-type: none"> • Program Participation Status • Special Education Program Services Descriptor

Resource Toggle/Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	When a resource is toggled to off after data has sent, all sent data remains in the ODS but no new data will send.
Resync	When a record is in the Ed-Fi Identity Mapping table and not in the ODS, it is deleted from the Ed-Fi Identity Mapping table.
Resync	When a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it is deleted from the ODS.
Resync	When a mapping is changed in Resource Preferences, a resync needs to be done to reflect the changes.

Action	Trigger
Resync	When the Student Special Education Program Association is toggled off, records are not deleted from this resource in the State ODS when resyncing.
