

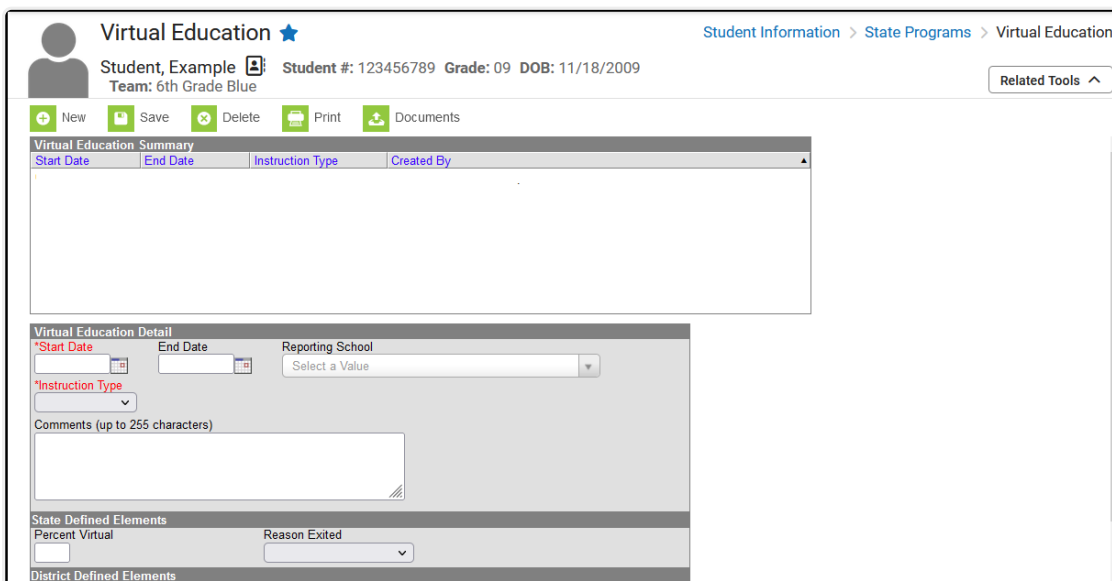

The Virtual Education tool allows districts to track and report the time a student participates in virtual learning as defined by the state of Indiana. It incorporates the 'Virtual Student' and 'Distance Learning' data components that are currently located under the State Reporting Fields section of the [Enrollment](#) record.

## Add a Virtual Education Record

1. Click the **New** button. A Virtual Education Detail editor displays.
2. Enter the applicable information for the student.
3. Click the **Save** icon when finished. The saved record displays in the Virtual Education summary.
