Object Triggering Logic | Object Data Elements

Tool Search: Ed-Fi

This association represents the McKinney-Vento Homeless Program program(s) that a student participates in or from which the Student receives services.

Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	When a Homeless record overlaps the configured year and the student has an enrollment in the configured year. • Does not send a record when an enrollment is in a calendar marked as Exclude. • Does not send a record when an enrollment is in a school marked as Exclude. • Does not send a record when enrollment is marked as No Show or State Exclude.
Delete/Post	When any field part of the natural key is changed: • Start Date
Put	When any field not part of the natural key is changed. • End Date • Primary Night Time Residence • Unaccompanied Youth
Delete	All enrollments are deleted for a student.
Delete	When the student's enrollment is marked as No Show or State Exclude.
Delete	When the Homeless record is deleted.
Delete	When the start/end dates on the Homeless record are updated so the record no longer overlaps the configured year.

School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	When a resource is toggled to OFF after data has sent, all sent data remains in the ODS but no new data is sent.
Resync	When a record is in the Ed-Fi Identity Mapping table and not in the ODS, it is deleted from the Ed-Fi Identity Mapping table.
Resync	When a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it is deleted from the ODS.



Action	Trigger
Resync	When a mapping is changed in Resource Preferences, a resync is needed to reflect the changes.

Natural Key Changes, Cascading Updates, and Deletes Logic

This table describes the Natural Key Changes/Cascading Updates and Deletes logic of this object.

Action	Trigger
Post/Delete	 Natural Key changes: LEA Reference - District Numbers cannot change after data has been sent. When a district number changes, an error is expected and this change would not be supported. When an Ed-Fi ID changes, a delete/post occurs with the cascading deletes from the Ed-Fi ID Change triggers. When the Program Name or Program Type Descriptor mapping changes and a resync is completed. When the Start Date of the program record changes.
Delete	Cascading Deletes: N/A - no dependent resources.

Scope Year Logic

This table describes scope year logic of this object.

Logic

The record sends to any year the homeless record overlaps with when the student has an enrollment in that year.

Data only sends for the years that have a valid configuration.

homelessProgramServices	Indicates the service(s) being provided to the Student by the Homeless Program. This is optional and does not report.	0	
homelessUnaccompaniedYouth	A homeless unaccompanied youth is a youth who is not in the physical custody of a parent or guardian and who fits the McKinney-Vento definition of homeless. Students must be both unaccompanied and homeless to be included as an unaccompanied homeless youth. When the Unaccompanied Youth fields is set to No and Primary Night Time Residence code is 1, 2, 3 or 4, reports a value of 1. Then Otherwise, reports a value of zero (0). reasonExitedDescriptor	This descriptor defines the reason a student exited a program. This is optional and does not report.	0
