## DTaP

Rule	Requirements
<b>6 months and younger</b> <i>No Requirement</i>	Students 6 months old and younger are not required to receive any doses of the DTaP vaccine.
<b>3 doses (7-18 months)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>they are at least 7 months, but no older than 18 months old, and</li> <li>they receive three doses of the DTaP vaccine.</li> </ul>
<b>4 doses (under 4 years)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>they are at least 19 months, but no older than 47 months old, and</li> <li>they receive four doses of the DTaP vaccine.</li> </ul>

<b>4 doses (4 years and older)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they receive four doses of the DTaP vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>
<b>Default</b> <i>Non-Compliant</i>	N/A

## Polio

Rule	Requirements
<b>4 months and younger</b> <i>No requirement</i>	Students 4 months old and younger are not required to receive any IPV or IPV/OPV Polio vaccine doses.
<b>18 years and older</b> <i>No Requirement</i>	Students 216 months (18 years) old or older are not required to receive any IPV or IPV/OPV Polio vaccine doses.
<b>2 doses (5-18 months)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 5 months, but no older than 18 months old, and</li> <li>• they receive two doses of the IPV or IPV/OPV Polio vaccine.</li> </ul>
<b>3 doses (under 4 years)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 19 months, but no older than 47 months old, and</li> <li>• they receive three doses of the IPV or IPV/OPV Polio vaccine.</li> </ul>
<b>3 doses (4 years and older)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• They are at least 48 months, and</li> <li>• they receive three doses of the IPV or IPV/OPV Polio vaccine.</li> <li>• the difference between the third dose and previous dose is greater than or equal to 6 months with a 4 day tolerance.</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>
<b>2 doses (4 years and older)</b> <i>In Progress</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• They are at least 48 months, and</li> <li>• they receive three doses of the IPV or IPV/OPV Polio vaccine.</li> <li>• the difference between the last dose and the student's birthdate is less than 5 months with a 1 day tolerance (looks for doses within 6 months of the student's birthdate)</li> </ul>

<b>4 doses (4 years and older)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 48 months,</li> <li>• they receive four doses of the IPV or IPV/OPV Polio vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 48 months with a 4 day tolerance.</li> </ul>
<b>Default</b> <i>Non-Compliant</i>	N/A

## Hepatitis B

Rule	Requirements
<b>2 months and younger</b> <i>No Requirement</i>	Students 2 months old and younger are not required to receive any doses of the Hepatitis B vaccine.
<b>1 dose (3-4 months)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 3 months, but no older than 4 months old, and</li> <li>• they receive one dose of the Hepatitis B vaccine.</li> </ul>
<b>2 doses (5-18 months)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 5 months, but no older than 18 months old, and</li> <li>• they receive two doses of the Hepatitis B vaccine.</li> </ul>
<b>3 doses (19 months and older)</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• the student is at least 19 months old,</li> <li>• the student receives three doses of the Hepatitis B vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 168 days (24 weeks) with a 4-day tolerance.</li> </ul>

## Measles Mumps Rubella

<b>11 months and younger</b> <i>No Requirement</i>	Students 11 months old and younger are not required to receive any doses of the Measles Mumps Rubella (MMR) vaccine.

<p><b>1 dose 12-15 months</b> <i>Compliant</i></p>	<p>Students are considered compliant when:</p> <ul style="list-style-type: none"> <li>• they are no older than 15 months old,</li> <li>• they receive one dose of the Measles, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance, OR</li> </ul> </li> <li>• they receive one dose of the Mumps, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance, OR</li> </ul> </li> <li>• they receive one dose of the Rubella, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul> </li> </ul>
<p><b>2 doses M &amp; M, 1 dose R</b> <i>Compliant</i></p>	<p>Students are considered compliant when:</p> <ul style="list-style-type: none"> <li>• they receive two doses of the Measles, MMR, or MMRV vaccine,               <ul style="list-style-type: none"> <li>◦ the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and</li> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance, OR</li> </ul> </li> <li>• they receive two doses of the Mumps, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance, AND</li> </ul> </li> <li>• they receive one dose of the Rubella, MMR, or MMRV vaccine, and               <ul style="list-style-type: none"> <li>◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul> </li> </ul>

## Tetanus-Diphtheria and Acellular Pertussis Tdap

<b>1 dose 12 and older</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 144 months (12 years) old, and</li> <li>• they receive one dose of the DTaP or Tdap vaccine.</li> </ul>
<b>1 dose 7th grade and up</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are in state grades 07, 08, 09, 10, 11, or 12, and</li> <li>• they receive one dose of the DTaP or Tdap vaccine.</li> </ul>
<b>No doses 12 and Older</b> <i>Non-Compliant</i>	Students are considered non-compliant when: <ul style="list-style-type: none"> <li>• they are at least 144 months (12 years) old, and</li> <li>• they have not received any doses of the DTaP or Tdap vaccine.</li> </ul>

Rule	Requirements
<b>No doses 7th grade and up</b> <i>Non-Compliant</i>	Students are considered non-compliant when: <ul style="list-style-type: none"> <li>• they are in state grades 07, 08, 09, 10, 11, or 12, and</li> <li>• they have not received any doses of the DTaP or Tdap vaccine.</li> </ul>
<b>Default</b> <i>No Requirement</i>	N/A

## Meningococcal

Rule	Requirements
<b>1 dose after 16</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they receive one dose of the MCV4 or MenACWY vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 192 months with a 4-day tolerance.</li> </ul>
<b>2 doses 17 and older</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 204 months (17 years) old, and</li> <li>• they receive two doses of the MCV4 or MenACWY vaccine.</li> </ul>
<b>1 dose 17 and older</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 204 months (17 years) old, and</li> <li>• they receive one dose of the MCV4 or MenACWY vaccine.</li> </ul>
<b>2 dose 12th grade</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are in state grade 12, and</li> <li>• they receive two doses of the MCV4 or MenACWY vaccine.</li> </ul>
<b>1 dose 12th grade</b> <i>Non-Compliant</i>	Students are considered non-compliant when: <ul style="list-style-type: none"> <li>• they are in state grade 12, and</li> <li>• they receive one dose of the MCV4 or MenACWY vaccine.</li> </ul>
<b>1 dose 12-16 years</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 144 months, but no older than 203 months, and</li> <li>• they receive one dose of the MCV4 or MenACWY vaccine</li> </ul>

Rule	Requirements
<b>1 dose 7-11th grade</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are no older than 203 months,</li> <li>• they are in state grades 07, 08, 09, 10, or 11, and</li> <li>• they receive one dose of the MCV4 or MenACWY vaccine.</li> </ul>
<b>No Doses 12 and older</b> <i>Non-Compliant</i>	Students are considered non-compliant when: <ul style="list-style-type: none"> <li>• they are at least 144 months old, and</li> <li>• they have not received any doses of the MCV4 or MenACWY vaccine.</li> </ul>
<b>No Doses 7-12th grade</b> <i>Non-Compliant</i>	Students are considered non-compliant when: <ul style="list-style-type: none"> <li>• they are in state grades 07, 08, 09, 10, 11, or 12, and</li> <li>• they have not received any doses of the MCV4 or MenACWY vaccine.</li> </ul>
<b>Default</b> <i>No Requirement</i>	N/A

## Pneumococcal

Rule	Requirements
<b>6 months and younger</b> <i>No Requirement</i>	Students 6 months old and younger are not required to receive any doses of the Pneumococcal vaccine.
<b>5 years and older</b> <i>No Requirement</i>	Students 60 months (5 years) old and older are not required to receive any doses of the Pneumococcal vaccine.
<b>3 doses 7-11 months</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 7 months, but no older than 11 months, and</li> <li>• they receive three doses of the Pneumococcal (PCV or PPV) vaccine.</li> </ul>
<b>4 doses 12 months and older</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they are at least 12 months old,</li> <li>• they receive four doses of the Pneumococcal (PCV or PPV) vaccine, and</li> <li>• the difference between the first dose and the student's birthdate is less than 6 months with a 1-day tolerance (looks for doses within 7 months of the student's birthdate).</li> </ul>

<p><b>3 dose catch up</b> <i>Compliant</i></p>	<p>Students are considered compliant when:</p> <ul style="list-style-type: none"> <li>• they receive three doses of the Pneumococcal (PCV or PPV) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 6 months with a 1-day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 11 months with a 1-day tolerance ((looks for doses within 12 months of the student's birthdate),</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul>
<p><b>2 dose catch up</b> <i>Compliant</i></p>	<p>Students are considered compliant when:</p> <ul style="list-style-type: none"> <li>• they receive two doses of the Pneumococcal (PCV or PPV) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 23 months with a 1-day tolerance (looks for doses within 24 months of the student's birthdate), and</li> <li>• the difference between the second and previous dose is greater than or equal to 56 days with a 4 day tolerance.</li> </ul>

<b>1-2 dose catch up</b> <i>In Progress</i>	Students are considered in progress when: <ul style="list-style-type: none"> <li>• they receive one dose of the Pneumococcal (PPV) vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 23 months with a 1-day tolerance (looks for doses within 24 months of the student's birthdate), and</li> <li>• the difference between the last dose and effective date is less than or equal to 56 days with a 4-day tolerance.</li> </ul>
<b>Default</b> <i>Non-Compliant</i>	N/A

## Hib

Rule	Requirements
<b>5 years and older</b> <i>No Requirement</i>	Students 60 months (5 years) old and older are not required to receive any doses of the Hib vaccine.
<b>3 doses</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they receive three doses of the Hib vaccine,</li> <li>• the difference between the second dose and the student's birthdate is less than or equal to 6 months with a 1-day tolerance (looks for doses within 7 months of the student's birthdate), and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul>
<b>3 dose catch up 7-12 months</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they receive three doses of the Hib vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 7 months with a 4-day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 11 months with a 1-day tolerance (looks for doses within 12 months of the student's birthdate), and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul>

Rule	Requirements
<b>3 dose catch up 12-15 months</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they receive three doses of the Hib vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 14 months with a 1-day tolerance (looks for doses within 15 months of the student's birthdate), and</li> <li>• the difference between the third and previous dose is greater than or equal to 2 months with a 4 day tolerance.</li> </ul>
<b>1 dose catch up</b> <i>Compliant</i>	Students are considered compliant when: <ul style="list-style-type: none"> <li>• they receive one dose of the Hib vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 15 months with a 4-day tolerance.</li> </ul>
<b>2-3 dose catch up 12-15 months</b> <i>In Progress</i>	Students are considered in progress when: <ul style="list-style-type: none"> <li>• they receive two doses of the Hib vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance,</li> <li>• the difference between the first dose and the student's birthdate is less than 14 months with a 1-day tolerance (looks for doses within 15 months of the student's birthdate), and</li> <li>• the difference between the last dose and the effective date is less than one month with 1-day tolerance (looks for doses in the last 2 months).</li> </ul>
