It is recommended that customers apply all subsequent Release Packs immediately following Rx Packs. Doing so will benefit both customers and Infinite Campus when it comes to supporting the patch.

Rx Packs are cumulative; each Rx pack will automatically include all previous Rx packs within that release. These cases will also be included in the Campus.2419 pack unless otherwise noted. Rx Packs may occasionally skip a release number for Rx builds that were not made generally available.

Note: It is recommended that changes to this system preference be made during off-peak hours. Users with open sessions may experience issues if this setting is changed during their session. These issues are resolved when the user logs into Infinite Campus and starts a new session.
