

# Discipline Incidents (Arizona 7.1)

This event entity represents an occurrence of an infraction ranging from a minor behavioral problem that disrupts the orderly functioning of a school or classroom (such as tardiness) to a criminal act that results in the involvement of a law enforcement official (such as robbery). A single event (e.g., a fight) is one incident regardless of how many perpetrators or victims are involved. Discipline incidents are events classified as warranting discipline action.

## Object Triggering

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	<p>Reports a behavior incident when the incident's Status is marked and saved as Complete.</p> <ul style="list-style-type: none"> <li>• The incident must have at least one behavior event associated and the event is mapped to an Ed-Fi Value.</li> <li>• The incident must be tied to a Behavior Incident that has at least one Behavior Resolution that is mapped to an Ed-Fi Value.</li> <li>• Student must be in SPED or 21st CCLC on the date of the reported behavior event, OR the event/resolution must be related to firearms. This is identified by: <ul style="list-style-type: none"> <li>◦ SPED <ul style="list-style-type: none"> <li>▪ Student has a locked IEP that overlaps the dates of the reported behavior event.</li> <li>▪ Student has no IEPs and has a flag with a state code of '999' (IEP) that overlaps the dates of the reported behavior event.</li> </ul> </li> <li>◦ 21st CCLC <ul style="list-style-type: none"> <li>▪ A student has an enrollment in a school where the 21CCLC checkbox is marked on the School Resource within the scope year.</li> </ul> </li> <li>◦ Firearms <ul style="list-style-type: none"> <li>▪ The Behavior Event is mapped to one of the following values: <ul style="list-style-type: none"> <li>▪ Handguns</li> <li>▪ Rifles/shotguns</li> <li>▪ Multiple firearms</li> <li>▪ Other Firearms</li> </ul> </li> </ul> </li> </ul> </li> <li>• Posting can occur when a new event is added after Incident is marked as Complete.</li> <li>• Do not send when the student is in a calendar marked as Exclude.</li> <li>• Do not send when the student is in a School marked as Exclude.</li> <li>• Do not send when the student's enrollment is marked as State Exclude.</li> <li>• Do not send when the student's grade is marked as State Exclude.</li> <li>• Do not send when a student's enrollment is marked as No Show.</li> </ul>
Put	<p>When data that is not part of the Natural Key is changed.</p> <ul style="list-style-type: none"> <li>• When Submitted By is changed on the incident.</li> <li>• When a new behavior event is added, changed or removed.</li> <li>• When the incident date is changed.</li> </ul>
Delete/Post	<p>When the Incident's status is changed.</p> <ul style="list-style-type: none"> <li>• Delete when the status is changed from Completed to In Progress.</li> <li>• Post when the status is changed from In Progress to Completed.</li> </ul>
Delete/Post	<p>When a student's SPED IEP is changed.</p> <ul style="list-style-type: none"> <li>• Delete when the IEP is unlocked.</li> <li>• Post when the IEP is locked.</li> <li>• Delete when IEP dates are updated to no longer overlap the behavior incident.</li> <li>• Post when IEP dates are updated to now overlap the behavior incident.</li> </ul>

Action	Trigger
Delete/Post	<p>When student's flag with a state code of 999 (IEP) is changed.</p> <ul style="list-style-type: none"> <li>• Delete when flag dates are updated to no longer overlap the behavior incident.</li> <li>• Post when flag dates are updated to now overlap the behavior incident.</li> <li>• Delete when a flag with dates that overlaps the behavior incident is deleted.</li> <li>• Post when a flag with dates that overlaps the behavior incident has the program updated to 999 (IEP) or a new flag is added with a program state code of 999 (IEP).</li> </ul>
Delete/Post	<p>When the student's 21st CCLC record is changed.</p> <ul style="list-style-type: none"> <li>• Delete when 21st CCLC dates are updated to no longer overlap the school year of the reported behavior event.</li> <li>• Post when 21st CCLC dates are updated to now overlap the school year of the reported behavior incident.</li> <li>• Delete when the 21st CCLC record with dates that overlap the school year of the reported behavior incident is deleted.</li> </ul>
Delete	When an incident is deleted.
Delete	When the associated student enrollment is deleted.
Delete	When all Student Discipline Incident Associations are deleted that are associated with this Disciple Incident record.

## Resource Toggle/Resync

Action	Business Rule
None	When a resource is toggled to OFF after data has sent, all sent data remains in the ODS but no new data is sent.
Resync	When a record is in the Ed-Fi Identity Mapping table and not in the ODS, it is deleted from the Ed-Fi Identity Mapping table.
Resync	When a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it is deleted from the ODS.
Resync	When a mapping is changed in Resource Preferences, a resync needs to be done to reflect the changes.

## Natural Key Changes/Cascading Updates, Deletes

Action	Business Rule
Post/Delete	<p>Natural Key changes:</p> <ul style="list-style-type: none"> <li>• When the School Number/Ed-Fi School Number changes, a delete/post occurs with the cascading deletes from the School ID Change triggers. When an Ed-Fi ID changes, this happens with the cascading deletes from the Ed-Fi ID Change trigger.</li> </ul>
Delete/Post	<p>When the Incident is deleted all dependent resources are deleted.</p> <ul style="list-style-type: none"> <li>• Student Discipline Incident Associations, Discipline Action</li> </ul>

## Scope Year

Business Rules
Discipline records only send to the school year to which they are aligned.

Data only sends for the years that have valid configuration.
