This entity is the final record of a student's performance in their courses at the end of a semester or school year.

## Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	<p>When transcript records are posted for a student for course with a state code and in grades 9-12.</p> <p>When a grade is posted to a grading task that is marked as State Reported and the student is in grades K-8.</p> <ul style="list-style-type: none"> <li>• Only reports transcript records where the record's school number is equal to the school number where the student is enrolled. Only reports records for the school year the enrollment is aligned to.</li> <li>• Does not report when posted from a course in an excluded calendar. When a transcript record is manually entered, only reports when the student has an enrollment in a calendar not marked as excluded.</li> <li>• Does not report when the Course is marked as inactive or State Excluded.</li> </ul>
Post/Delete	When a grade is changed on a state reported grading task or part of the Natural Key is changed.
Put	When fields that are not part of the natural key are changed.
Delete	When a transcript record is deleted for a student.
Delete	When a state reported grade is deleted for a student.
Delete	<p>Transcript records are deleted when a student has only one Student School Association record for a specific School and Year and that record is deleted.</p> <p>Note: When a new Student School Association record is created, existing records does not re-post, a resync must be completed to resend the data.</p>
Delete	<p>When the Enrollment State Exclude checkbox is checked.</p> <p>Note: When the box is unchecked the data does not post, a resync must be completed to resend the data.</p>
Delete	When the District Number on the course transcript is changed and it no longer matches the reporting districts number.

## School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	When a resource is toggled to 'OFF' after data has sent, all sent data remains in the ODS but no new data is sent.
Resync	When a record is in the Ed-Fi Identity Mapping table and not in the ODS, it is deleted from the Ed-Fi Identity Mapping table.
Resync	When a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it is deleted from the ODS.
Resync	When a mapping is changed in Resource Preferences, a resync is needed to be done to reflect the changes.

## Natural Key Changes, Cascading Updates, and Deletes Logic

This table describes the Natural Key Changes/Cascading Updates and Deletes logic of this object.

Action	Trigger
Post/Delete	Natural Key change: <ul style="list-style-type: none"> <li>• When the Natural Key changes from the Course Reference or Student Academic Reference, the cascading delete/post logic from those resources triggers updates to the Course Transcripts.</li> <li>• Records delete/post when the Credits Earned or Credits Attempted are changed on a student's transcript record.</li> </ul>

## Scope Year Logic

This table describes scope year logic of this object.

Logic
Transcript records send to each scope year where the student has a Student School Association, regardless of the Transcript School Year. <ul style="list-style-type: none"> <li>• Data only sends for years that have valid configuration.</li> <li>• A resync must be completed at the beginning of each year so that all years transcript records are loaded in the ODS.</li> </ul>
