DTaP

Rule	Requirements
before 3 months <i>No Requirement</i>	Students 3 months old and younger are not required to receive any doses of the DTaP vaccine.
1 dose <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 3 months old but no older than 4 months old, • they receive 1 dose of the DT, Tdap, Td, or DTaP vaccine, and • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance.

Rule	Requirements
2 doses <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 5 months old but no older than 6 months old, • they receive 2 doses of the DT, Tdap, Td, or DTaP vaccine, • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance.
3 doses <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 7 months old but no older than 18 months old, • they receive 3 doses of the DT, Tdap, Td, or DTaP vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and • the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance.
4 doses under 4 years <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 19 months old but no older than 47 months old, • they receive 4 doses of the DT, Tdap, Td, or DTaP vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, • the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance, and • the difference between the fourth and previous dose is greater than 6 months with a 4-day tolerance.
4 doses <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 48 months old but no older than 83 months old, • they receive 4 doses of the DT, Tdap, Td, or DTaP vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, • the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance, • the difference between the fourth and previous dose is greater than 6 months with a 4-day tolerance, and • the difference between the fourth dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.

<p>5 doses <i>Compliant</i></p>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> • they are at least 48 months old but no older than 83 months old, • they receive 5 doses of the DT, Tdap, Td, or DTaP vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, • the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance, • the difference between the fourth and previous dose is greater than 6 months with a 4-day tolerance, and • the difference between the fifth and previous dose is greater than or equal to 6 months with a 4-day tolerance.
<p>3 doses age 7+ <i>Compliant</i></p>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> • they is at least 84 months old, • they receive 3 doses of the DT, Tdap, Td, or DTaP vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and • the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance.
<p>5th doses <i>In Progress</i></p>	<p>Students are in progress when:</p> <ul style="list-style-type: none"> • they receive 4 doses of the DT, Tdap, Td, or DTaP vaccine, and • the difference between the last dose and the effective date is less than or equal to 6 months with a 0-day tolerance. <p>This means that when a student has 4 doses and the last dose is less than or equal to 6 months from the effective date and the student is not compliant, the student is considered in progress.</p>
<p>4th dose <i>In Progress</i></p>	<p>Students are in progress when:</p> <ul style="list-style-type: none"> • they receive 3 doses of the DT, Tdap, Td, or DTaP vaccine, and • the difference between the last dose and the effective date is less than or equal to 6 months with a 0-day tolerance. <p>This means that when a student has 3 doses and the last dose is less than or equal to 6 months from the effective date and the student is not compliant, the student is considered in progress.</p>

Rule	Requirements
3rd dose age 7+ <i>In Progress</i>	<p>Students are in progress when:</p> <ul style="list-style-type: none"> • they are at least 84 months old, • they receive 2 doses of the DT, Tdap, Td, or DTaP vaccine, and • the difference between the last dose and the effective date is less than or equal to 6 months with a 0-day tolerance. <p>This means that when a student has 2 doses and the last dose is less than or equal to 6 months from the effective date and the student is not compliant, the student is considered in progress.</p>
2nd dose <i>In Progress</i>	<p>Students are in progress when:</p> <ul style="list-style-type: none"> • they receive 1 dose of the DT, Tdap, Td, or DTaP vaccine, and • the difference between the last dose and the effective date is less than or equal to 28 days with a 0-day tolerance. <p>This means that when a student has 1 dose, and the dose is less than or equal to 6 months from the effective date and the student is not compliant, the student is considered in progress.</p>

18 years and older <i>Compliant</i>	<p>Students 216 months and older are not required to receive any doses of the IPV, OPV, or IPV/OPV combined Polio vaccine.</p>
4 doses 4-6 yrs <i>Compliant</i>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> • they are at least 48 months old but no older than 83 months old, • they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, • they receive 4 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, • the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance, and • the difference between the fourth and previous dose is greater than or equal to 28 days with a 4-day tolerance.

3 doses 7 yrs <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 84 months old, and • they receive 3 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine.
Dose space K-12 <i>In Progress</i>	Students are in progress when: <ul style="list-style-type: none"> • they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, • they receive 1 dose of the IPV, OPV, or IPV/OPV combined Polio vaccine, and • the difference between the last dose and the effective date is less than 28 days with a 0-day tolerance.
Default K-12 <i>Non-compliant</i>	Students are considered non-compliant when they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12 and have not received any doses of the IPV, OPV, or IPV/OPV combined Polio vaccine.
2 mos <i>No Requirement</i>	Students 2 months old and younger are not required to receive any doses of the IPV, OPV, or IPV/OPV combined Polio vaccine.
3-4 mos <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 3 months old but no older than 4 months old, • they receive 1 dose of the IPV, OPV, or IPV/OPV combined Polio vaccine, and • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance.

5-18 mos <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 5 months old but no older than 18 months old, • they receive 2 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, and • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance.
19 months and older <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 19 months old, • they receive 3 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and • the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance.
Dose space <i>In Progress</i>	Students are in progress when they receive a dose of the IPV, OPV, or IPV/OPV combined Polio vaccine in the last 28 days with a 0-day tolerance.

2 doses MMR <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, • they receive 2 doses of the MMR or MMRV vaccine, • the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day, and • the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance.

2M, 1M, 1R <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, • they receive 2 doses of the Measles vaccine, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day, and ◦ the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, • they receive 1 dose of the Mumps vaccine, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day, • they receive 1 dose of the Rubella vaccine, <ul style="list-style-type: none"> ◦ the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day.

Default K-12 <i>Non-compliant</i>	Students are considered non-compliant when they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and they have not received any doses of the MMR or MMRV vaccine.
0-14 months <i>No Requirement</i>	Students 14 months old and younger are not required to receive any doses of the MMR or MMRV vaccine.

Rule	Requirements
1MMR 15 months and older <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are at least 15 months old, and they have received 1 dose of the MMR or MMRV vaccine.
1M 1M 1R 15 months and older <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are at least 15 months old, they have received 1 dose of the Measles vaccine, they have received 1 dose of the Mumps vaccine, they have received 1 dose of the Rubella vaccine.
Default <i>Non-Compliant</i>	N/A

Hepatitis B

Rule	Requirements
1 dose <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are no older than 2 months old, they receive 1 dose of the Hepatitis B vaccine.
2 doses <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are at least 3 months old but no older than 18 months old, they receive 2 doses of the Hepatitis B vaccine, the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance.
2 doses age 11+ <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are at least 132 months old, and they receive 2 doses of the Hepatitis B vaccine.
3 doses <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they receive 3 doses of the Hepatitis B vaccine, the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, the difference between the third and previous dose is greater than or equal to 56 days with a 4-day tolerance, the difference between the third and two doses previous is greater than or equal to 112 with a 4-day tolerance.
3rd dose <i>In Progress</i>	Students are in progress when they have received 2 doses of the Hepatitis B vaccine, and the last dose was administered within the last 56 days with a 0-day tolerance.

Rule	Requirements
3rd dose <i>In Progress</i>	Students are in progress when they have received 2 doses of the Hepatitis B vaccine, and the second-to-last dose was administered within the last 112 days with a 0-day tolerance.
2nd dose <i>In Progress</i>	Students are in progress when they have received one dose of the Hepatitis B vaccine, and the last dose was administered within the last 28 days with a 0-day tolerance.
Default <i>Non-Compliant</i>	N/A

Haemophilus influenzae type B Hib

Rule	Requirements
0-1 months <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Hib vaccine.
2-11 months <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 2 months old but no older than 11 months old, and • they receive 2 doses of the Hib vaccine.
12-59 months <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 12 months old but no older than 59 months old, • they receive 1 dose of the Hib vaccine, and • the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.
2-59 months <i>Non-compliant</i>	Students aged 2-59 months who have not received any doses of the Hib vaccine are non-compliant.
60 months <i>No Requirement</i>	Students 60 months old and older are not required to receive any Hib doses.

Pneumococcal

Rule	Requirements
0-1 months <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Pneumococcal vaccine.

Rule	Requirements
2-11 months <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are at least 2 months old but no older than 11 months old, and they receive 2 doses of the Pneumococcal (PPV or PCV) vaccine.
12-59 months <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they are at least 12 months old but no older than 59 months old, they receive 1 dose of the Pneumococcal (PPV or PCV) vaccine, and the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.
2-59 months <i>Non-compliant</i>	Students aged 2-59 months who have not received any doses of the Pneumococcal vaccine are non-compliant.
60 months <i>No Requirement</i>	Students 60 months old and older are not required to receive any Pneumococcal doses.

Varicella

Rule	Requirements
born before 1/1/1998 <i>No Requirement</i>	Students born before 1/1/1998 are not required to receive any Varicella doses.
0-18 months <i>No Requirement</i>	Students 18 months old or younger are not required to receive any Varicella doses.
1 dose <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> they were born after 1/1/1998, they receive 1 dose of the Varicella or MMRV vaccine, and the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.
Default <i>Non-compliant</i>	N/A

Tetanus Diphtheria and Acellular Pertussis Tdap

Rule	Requirements
5 Year Booster <i>No Requirement</i>	Students are not required to receive any doses of the Tdap vaccine when: <ul style="list-style-type: none"> • they are at least 132 months old, • they are in state grade(s) 06, 07, 08, 09, 10, 11, or 12, • they receive 1 dose of the DT, Td, or DTaP/DTP vaccine, and • they received the dose in the last 59 months with a 0-day tolerance.
5 Year Booster <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 132 months old, • they are in state grade(s) 06, 07, 08, 09, 10, 11, or 12, and • they receive 1 dose of the Tdap vaccine.
1 dose <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they are at least 132 months old, • they are in state grade(s) 06, 07, 08, 09, 10, 11, or 12, • they receive 1 dose of the DT, Td, or DTaP/DTP vaccine, and • the difference between the last dose and the student's birthdate is greater than or equal to 132 months with a 4-day tolerance.
6th Grade + <i>Non-compliant</i>	Students are non-compliant when: <ul style="list-style-type: none"> • they are at least 132 months old, • they are in state grade(s) 06, 07, 08, 09, 10, 11, or 12, and • they haven't received any Tdap doses.
Default <i>No Requirement</i>	N/A

Meningococcal

Rule	Requirements
1 dose <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> • they were born on or after 1/1/1997, • they are in state grade 06, and • they receive 1 dose of the MenACWY or MCV4 Meningococcal vaccine.
Default 6th grade <i>Non-compliant</i>	Students are non-compliant when: <ul style="list-style-type: none"> • they were born on or after 1/1/1997, • they are in state grade 06, and • they have not received any doses of the MenACWY or MCV4 Meningococcal vaccine.

Rule	Requirements
Default <i>No Requirement</i>	N/A
