## DTaP

Rule	Requirements
<b>before 3 months</b> <i>No Requirement</i>	Students 3 months old and younger are not required to receive any doses of the DTaP vaccine.
<b>1 dose</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are at least 3 months old but no older than 4 months old,</li> <li>• they receive 1 dose of the DT, Tdap, Td, or DTaP vaccine, and</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance.</li> </ul>

Rule	Requirements
<b>2 doses</b> <i>Compliant</i>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> <li>• they are at least 5 months old but no older than 6 months old,</li> <li>• they receive 2 doses of the DT, Tdap, Td, or DTaP vaccine,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance.</li> </ul>
<b>3 doses</b> <i>Compliant</i>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> <li>• they are at least 7 months old but no older than 18 months old,</li> <li>• they receive 3 doses of the DT, Tdap, Td, or DTaP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> </ul>
<b>4 doses under 4 years</b> <i>Compliant</i>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> <li>• they are at least 19 months old but no older than 47 months old,</li> <li>• they receive 4 doses of the DT, Tdap, Td, or DTaP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance,</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance, and</li> <li>• the difference between the fourth and previous dose is greater than 6 months with a 4-day tolerance.</li> </ul>
<b>4 doses</b> <i>Compliant</i>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> <li>• they are at least 48 months old but no older than 83 months old,</li> <li>• they receive 4 doses of the DT, Tdap, Td, or DTaP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance,</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than 6 months with a 4-day tolerance, and</li> <li>• the difference between the fourth dose and the student's birthdate is greater than or equal to 48 months with a 4-day tolerance.</li> </ul>

<b>5 doses</b> <i>Compliant</i>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> <li>• they are at least 48 months old but no older than 83 months old,</li> <li>• they receive 5 doses of the DT, Tdap, Td, or DTaP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance,</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance,</li> <li>• the difference between the fourth and previous dose is greater than 6 months with a 4-day tolerance, and</li> <li>• the difference between the fifth and previous dose is greater than or equal to 6 months with a 4-day tolerance.</li> </ul>
<b>3 doses age 7+</b> <i>Compliant</i>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> <li>• they is at least 84 months old,</li> <li>• they receive 3 doses of the DT, Tdap, Td, or DTaP vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> </ul>
<b>5th doses</b> <i>In Progress</i>	<p>Students are in progress when:</p> <ul style="list-style-type: none"> <li>• they receive 4 doses of the DT, Tdap, Td, or DTaP vaccine, and</li> <li>• the difference between the last dose and the effective date is less than or equal to 6 months with a 0-day tolerance.</li> </ul> <p>This means that when a student has 4 doses and the last dose is less than or equal to 6 months from the effective date and the student is not compliant, the student is considered in progress.</p>
<b>4th dose</b> <i>In Progress</i>	<p>Students are in progress when:</p> <ul style="list-style-type: none"> <li>• they receive 3 doses of the DT, Tdap, Td, or DTaP vaccine, and</li> <li>• the difference between the last dose and the effective date is less than or equal to 6 months with a 0-day tolerance.</li> </ul> <p>This means that when a student has 3 doses and the last dose is less than or equal to 6 months from the effective date and the student is not compliant, the student is considered in progress.</p>

Rule	Requirements
<b>3rd dose</b> <b>age 7+</b> <i>In Progress</i>	<p>Students are in progress when:</p> <ul style="list-style-type: none"> <li>• they are at least 84 months old,</li> <li>• they receive 2 doses of the DT, Tdap, Td, or DTaP vaccine, and</li> <li>• the difference between the last dose and the effective date is less than or equal to 6 months with a 0-day tolerance.</li> </ul> <p>This means that when a student has 2 doses and the last dose is less than or equal to 6 months from the effective date and the student is not compliant, the student is considered in progress.</p>
<b>2nd dose</b> <i>In Progress</i>	<p>Students are in progress when:</p> <ul style="list-style-type: none"> <li>• they receive 1 dose of the DT, Tdap, Td, or DTaP vaccine, and</li> <li>• the difference between the last dose and the effective date is less than or equal to 28 days with a 0-day tolerance.</li> </ul> <p>This means that when a student has 1 dose, and the dose is less than or equal to 6 months from the effective date and the student is not compliant, the student is considered in progress.</p>
<b>Default</b> <i>Non-compliant</i>	N/A

## Polio

Rule	Requirements
<b>18 years and older</b> <i>Compliant</i>	<p>Students 216 months and older are not required to receive any doses of the IPV, OPV, or IPV/OPV combined Polio vaccine.</p>
<b>4 doses 4-6 yrs</b> <i>Compliant</i>	<p>Students are compliant when:</p> <ul style="list-style-type: none"> <li>• they are at least 48 months old but no older than 83 months old,</li> <li>• they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>• they receive 4 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance,</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance, and</li> <li>• the difference between the fourth and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> </ul>

<b>Dose space K-12</b> <i>In Progress</i>	Students are in progress when: <ul style="list-style-type: none"> <li>• they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>• they receive 1 dose of the IPV, OPV, or IPV/OPV combined Polio vaccine, and</li> <li>• the difference between the last dose and the effective date is less than 28 days with a 0-day tolerance.</li> </ul>
<b>Default K-12</b> <i>Non-compliant</i>	Students are considered non-compliant when they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, or 12 and have not received any doses of the IPV, OPV, or IPV/OPV combined Polio vaccine.
<b>2 mos</b> <i>No Requirement</i>	Students 2 months old and younger are not required to receive any doses of the IPV, OPV, or IPV/OPV combined Polio vaccine.
<b>3-4 mos</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are at least 3 months old but no older than 4 months old,</li> <li>• they receive 1 dose of the IPV, OPV, or IPV/OPV combined Polio vaccine, and</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance.</li> </ul>

Rule	Requirements
<b>5-18 mos</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are at least 5 months old but no older than 18 months old,</li> <li>• they receive 2 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance, and</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> </ul>
<b>19 months and older</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are at least 19 months old,</li> <li>• they receive 3 doses of the IPV, OPV, or IPV/OPV combined Polio vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 42 days with a 4-day tolerance,</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance, and</li> <li>• the difference between the third and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> </ul>
<b>Dose space</b> <i>In Progress</i>	Students are in progress when they receive a dose of the IPV, OPV, or IPV/OPV combined Polio vaccine in the last 28 days with a 0-day tolerance.
<b>Default</b> <i>Non-compliant</i>	N/A

<b>2 doses MMR</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>• they receive 2 doses of the MMR or MMRV vaccine,</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day, and</li> <li>• the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> </ul>

Rule	Requirements

<b>Default K-12</b> <i>Non-compliant</i>	<p>Students are considered non-compliant when they are in state grade(s) DF: Full-day Transitional/Developmental KG, DH: Half-Day Transitional/Developmental KG, KF: Full-day Kindergarten, KH: Half-day Kindergarten, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, and they have not received any doses of the MMR or MMRV vaccine.</p>
<b>0-14 months</b> <i>No Requirement</i>	<p>Students 14 months old and younger are not required to receive any doses of the MMR or MMRV vaccine.</p>

Rule	Requirements
<b>1MMR 15 months and older</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they are at least 15 months old, and</li> <li>they have received 1 dose of the MMR or MMRV vaccine.</li> </ul>
<b>1M 1M 1R 15 months and older</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they are at least 15 months old,</li> <li>they have received 1 dose of the Measles vaccine,</li> <li>they have received 1 dose of the Mumps vaccine,</li> <li>they have received 1 dose of the Rubella vaccine.</li> </ul>
<b>Default</b> <i>Non-Compliant</i>	N/A

## Hepatitis B

Rule	Requirements
<b>1 dose</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they are no older than 2 months old,</li> <li>they receive 1 dose of the Hepatitis B vaccine.</li> </ul>
<b>2 doses</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they are at least 3 months old but no older than 18 months old,</li> <li>they receive 2 doses of the Hepatitis B vaccine,</li> <li>the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance.</li> </ul>
<b>2 doses age 11+</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they are at least 132 months old, and</li> <li>they receive 2 doses of the Hepatitis B vaccine.</li> </ul>
<b>3 doses</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they receive 3 doses of the Hepatitis B vaccine,</li> <li>the difference between the second and previous dose is greater than or equal to 28 days with a 4-day tolerance,</li> <li>the difference between the third and previous dose is greater than or equal to 56 days with a 4-day tolerance,</li> <li>the difference between the third and two doses previous is greater than or equal to 112 with a 4-day tolerance.</li> </ul>
<b>3rd dose</b> <i>In Progress</i>	Students are in progress when they have received 2 doses of the Hepatitis B vaccine, and the last dose was administered within the last 56 days with a 0-day tolerance.

Rule	Requirements
<b>3rd dose</b> <i>In Progress</i>	Students are in progress when they have received 2 doses of the Hepatitis B vaccine, and the second-to-last dose was administered within the last 112 days with a 0-day tolerance.
<b>2nd dose</b> <i>In Progress</i>	Students are in progress when they have received one dose of the Hepatitis B vaccine, and the last dose was administered within the last 28 days with a 0-day tolerance.
<b>Default</b> <i>Non-Compliant</i>	N/A

## Haemophilus influenza type B Hib

Rule	Requirements
<b>0-1 months</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Hib vaccine.
<b>2-11 months</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are at least 2 months old but no older than 11 months old, and</li> <li>• they receive 2 doses of the Hib vaccine.</li> </ul>
<b>12-59 months</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are at least 12 months old but no older than 59 months old,</li> <li>• they receive 1 dose of the Hib vaccine, and</li> <li>• the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul>
<b>2-59 months</b> <i>Non-compliant</i>	Students aged 2-59 months who have not received any doses of the Hib vaccine are non-compliant.
<b>60 months</b> <i>No Requirement</i>	Students 60 months old and older are not required to receive any Hib doses.

## Pneumococcal

Rule	Requirements
<b>0-1 months</b> <i>No Requirement</i>	Students 1 month old and younger are not required to receive any doses of the Pneumococcal vaccine.

Rule	Requirements
<b>2-11 months</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they are at least 2 months old but no older than 11 months old, and</li> <li>they receive 2 doses of the Pneumococcal (PPV or PCV) vaccine.</li> </ul>
<b>12-59 months</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they are at least 12 months old but no older than 59 months old,</li> <li>they receive 1 dose of the Pneumococcal (PPV or PCV) vaccine, and</li> <li>the difference between the first dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul>
<b>2-59 months</b> <i>Non-compliant</i>	Students aged 2-59 months who have not received any doses of the Pneumococcal vaccine are non-compliant.
<b>60 months</b> <i>No Requirement</i>	Students 60 months old and older are not required to receive any Pneumococcal doses.

## Varicella

Rule	Requirements
<b>born before 1/1/1998</b> <i>No Requirement</i>	Students born before 1/1/1998 are not required to receive any Varicella doses.
<b>0-18 months</b> <i>No Requirement</i>	Students 18 months old or younger are not required to receive any Varicella doses.
<b>1 dose</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>they were born after 1/1/1998,</li> <li>they receive 1 dose of the Varicella or MMRV vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 12 months with a 4-day tolerance.</li> </ul>
<b>Default</b> <i>Non-compliant</i>	N/A

## Tetanus Diphtheria and Acellular Pertussis Tdap

Rule	Requirements
<b>5 Year Booster</b> <i>No Requirement</i>	Students are not required to receive any doses of the Tdap vaccine when: <ul style="list-style-type: none"> <li>• they are at least 132 months old,</li> <li>• they are in state grade(s) 06, 07, 08, 09, 10, 11, or 12,</li> <li>• they receive 1 dose of the DT, Td, or DTaP/DTP vaccine, and</li> <li>• they received the dose in the last 59 months with a 0-day tolerance.</li> </ul>
<b>5 Year Booster</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are at least 132 months old,</li> <li>• they are in state grade(s) 06, 07, 08, 09, 10, 11, or 12, and</li> <li>• they receive 1 dose of the Tdap vaccine.</li> </ul>
<b>1 dose</b> <i>Compliant</i>	Students are compliant when: <ul style="list-style-type: none"> <li>• they are at least 132 months old,</li> <li>• they are in state grade(s) 06, 07, 08, 09, 10, 11, or 12,</li> <li>• they receive 1 dose of the DT, Td, or DTaP/DTP vaccine, and</li> <li>• the difference between the last dose and the student's birthdate is greater than or equal to 132 months with a 4-day tolerance.</li> </ul>
<b>6th Grade +</b> <i>Non-compliant</i>	Students are non-compliant when: <ul style="list-style-type: none"> <li>• they are at least 132 months old,</li> <li>• they are in state grade(s) 06, 07, 08, 09, 10, 11, or 12, and</li> <li>• they haven't received any Tdap doses.</li> </ul>
<b>Default</b> <i>No Requirement</i>	N/A

## Meningococcal

Rule	Requirements
