### Activity Registration Document Upload (SIS-183950) [Enhancement]

The [Activity Registration Document Upload](https://kb.infinitecampus.com/help/accept-or-decline-a-document-upload) (<https://kb.infinitecampus.com/help/accept-or-decline-a-document-upload>) feature allows students and parents to upload a specified number of documents when registering for an activity. Uploaded documents are displayed within the Activity Roster and posted to a designated location within Infinite Campus after approval by Activity Staff.

### Activity Registration Future Enrollment Fix (SIS-186756)

Fixed an issue where the "Preview Future Enrollments" functionality did not display all students who were capable of registering for activities. The "Include Future Enrollments" logic has been modified to better determine student eligibility. Districts that are using "Include Future Enrollments" are encouraged to review their "Preview Future Enrollments" results on the step 2 Preview and modify their ad hoc as needed.

- Fixed an issue where the Required label would disappear from the Registration Close Date field after an activity opened for registration, despite the field remaining mandatory.

- Fixed an issue where adding a new payment method and setting it as default did not immediately display it as the default.
- Fixed an issue where users were unable to proceed past step 1 when copying an activity in the Activity Dashboard that originally had waitlist enabled.

## Assessment

#### Student Identifier Strip Leading Zeros Update (SIS-178736)

In Steps 3 and 4 of the [Assessment Center](https://kb.infinitecampus.com/help/assessment-score-data-import#assessment-data-mapping-and-importing) (<https://kb.infinitecampus.com/help/assessment-score-data-import#assessment-data-mapping-and-importing>), leading zeros were displayed for the selected Student Identifier despite the 'Strip Leading Zeros' checkbox being marked. This caused matching errors when importing data that should not have leading zeros. This issue was corrected. When 'Strip Leading Zeros' is chosen for the Student Identifier field, the data in the mapping no longer displays nor imports leading zeros. The imported data matches the Student Identifier in the system.

### Duplicate Assessments in Records Transfers (SIS-183217)

Validations for importing [assessment data](https://kb.infinitecampus.com/help/assessment-student) (<https://kb.infinitecampus.com/help/assessment-student>) during [records transfers](https://kb.infinitecampus.com/help/records-transfer-student) (<https://kb.infinitecampus.com/help/records-transfer-student>) were updated to prevent duplicates. Users now receive a warning for the following scenarios:

- Assessments have already been imported for the CURRENT record transfer.
- Assessments exist in the database for the same test, person, and date.
- User successfully transfers a record with an assessment record that is not in the database.

### Information Icons Removed (SIS-185190)

The blue information icons in the data mapping column headers affected table scrolling and [data mapping/importing](https://kb.infinitecampus.com/help/assessment-score-data-import#assessment-data-mapping-and-importing) (<https://kb.infinitecampus.com/help/assessment-score-data-import#assessment-data-mapping-and-importing>) functions. To enhance user experience, the information icons were removed.

### Child Test Date Options Restored (SIS-187715)

There was an issue where child test date columns would lose their options button when [remapping a column](https://kb.infinitecampus.com/help/assessment-score-data-import) (<https://kb.infinitecampus.com/help/assessment-score-data-import>) after the "Apply to All Test Date Fields" checkbox was unchecked on the parent test date. All tests under the assessment hierarchy (child, grandchild, etc.) now retain their options button as expected.

- import if the parent test fails.
- save without a valid 'ParentID'.

An error message is generated to notify users that the Parent test creation failed.

'WARNING 1016' displays when a database column attribute is present in the imported file but not in the Core Attribute/Dictionary.
