

# National Records Exchange Tool Rights

National Records Exchange (NRE) allows student records to be exchanged among Campus districts across the nation. Any Campus district may participate in the [NRE](#), including districts that are currently DIS-connected to a Campus State Edition. This tool is only used to register for NRE.

National Records Exchange - Registration & Router Status

Once registration has been verified and authorized by Infinite Campus, Inc., districts will be able to perform district-to-district student records transfers with other authorized Infinite Campus districts.
