

SIF Data Tool and Record Deleter Tool Rights

The SIF Data Tool is only available in SIF-enabled instances of Infinite Campus. This tool is useful for reviewing SIF object data and troubleshooting specific SIF records that maybe be sending erroneous data or causing errors on the receiving end.

The SIF Record Deleter is only available for the SIF 2.7 framework. The SIF Record Deleter allows users to delete specific SIF records in an effort to assist in cleaning up troublesome SIF data such as orphaned records or records that were supposed to be excluded but were erroneously sent.

The SIF Objects will appear based on the Selection Options and only those Objects with the right Data Access Rights will appear.
This tool should not be used to mass delete records. The deletion process is intensive and takes time to complete which could cause issues if a mass deletion is executed.
