## **Prerequisites**


• To review school and district event statuses, the event must be <u>published to the</u> <u>districts/schools</u> and the certification window must be open or was open prior to the current date.

Users must have at least Read tool rights to the Event Management tool in order to review event details.


## **Reviewing Event Statuses and Details**

Click the **View** button within the Event Management tool to review the status and details of any data certification events.





Once selected, the Event Viewer will appear, providing details about the event. See the table below for more information about each section:

## **Event Details**

This section displays the event name, start and end date, certification level, description, reporting year, category, and status.

Districts/schools can only certify the event between the Certification Opens and Event End Date window.

Closed	The event has been closed.	Event not visible to Districts




